



### INVITATION TO BID

Bids received in excess of the ABC shall be automatically rejected at bid opening

#### Description

1. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
2. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
3. Interested bidders may obtain further information from BTA-BARMM and inspect the Bidding Documents at the address given below during office hours from 8:00 AM to 5:00 PM, Monday to Friday.
4. A complete set of Bidding Documents may be acquired by interested Bidders starting on September 22, 2020 from the address below and upon payment of non-refundable fee of Ten Thousand Pesos (Php 10,000.00) .

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

at the BTA Executive Lounge, Bangsamoro Government Center, Cotabato City which shall be open to prospective bidders.

6. Bids must be duly received by the BAC Secretariat at the address below on or before November 12, 2020, 8:30 AM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause.

7. Bid opening shall be on November 12, 2020, 9:00 AM at BTA Executive Lounge, Bangsamoro Government Center, Cotabato City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The BTA BARMM reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
