BANGSAMORO AUTONOMY ACT NO. 24

Begun and held in Cotabato City, on Friday, the 29th day of March, 2019.

**AN ACT
EXTENDING THE AVAILABILITY OF THE GENERAL APPROPRIATIONS ACT OF
THE BANGSAMORO UNTIL DECEMBER 31, 2022, EXCEPT PERSONNEL
SERVICES AND OTHER ITEMS OF THE MOOE, AMENDING FOR THE PURPOSE
SECTION 47 OF THE GENERAL PROVISIONS OF THE GENERAL
APPROPRIATIONS ACT OF THE BANGSAMORO FOR YEARS 2020 AND 2021**

Be it enacted by the Bangsamoro Transition Authority in Parliament assembled:

Section 1. Section 47 of the Bangsamoro Appropriations Act or Bangsamoro Autonomy Act No. 3 is hereby amended to read as follows:

"Sec. 47. Cash Budgeting System. All appropriations authorized in this Act shall be available for release and disbursement for the purpose specified, and under the same general and special provisions applicable thereto, until December 31, 2022.

For Fiscal Year 2020, the appropriations for infrastructure and capital outlays shall be valid for obligation until December 31, 2022 while the delivery, inspection, and payment shall be made not later than June 30, 2023. On the other hand, appropriations for the continuing programs under MOOE shall likewise be valid for obligation until December 31, 2022.

The appropriations for Personnel Services authorized in this Act shall be valid for obligation and disbursement only until December 31, 2020.

The MFBM is authorized to issue the necessary guidelines for the effective implementation of this Act."

Section 2. Section 47 of the Bangsamoro Appropriations Act or Bangsamoro Autonomy Act No. 15 is hereby amended to read as follows:

"Sec. 47. Cash Budgeting System. All appropriations authorized in this Act shall be available for obligation for the purpose specified, and under the same general and special provisions applicable thereto, until December 31, 2022.


For Fiscal Year 2021, the appropriations for infrastructure and capital outlays shall be valid for obligation until December 31, 2022 while the delivery, inspection, and payment shall be made not later than June 30, 2023. On the other hand, appropriations under MOOE shall be valid for obligation and disbursement until December 31, 2022.

The appropriations for Personnel Services authorized in this Act shall be valid for obligation and disbursement until December 31, 2021.

The MFBM is authorized to issue the necessary guidelines for the effective implementation of this Act."

Section 3. Repealing Clause. - All laws, decrees, executive issuances, rules and regulations inconsistent with this Act are hereby repealed or modified accordingly.

Section 4. Effectivity. - This Act shall take effect immediately after its publication in a newspaper of regional circulation in the Bangsamoro Autonomous Region.
