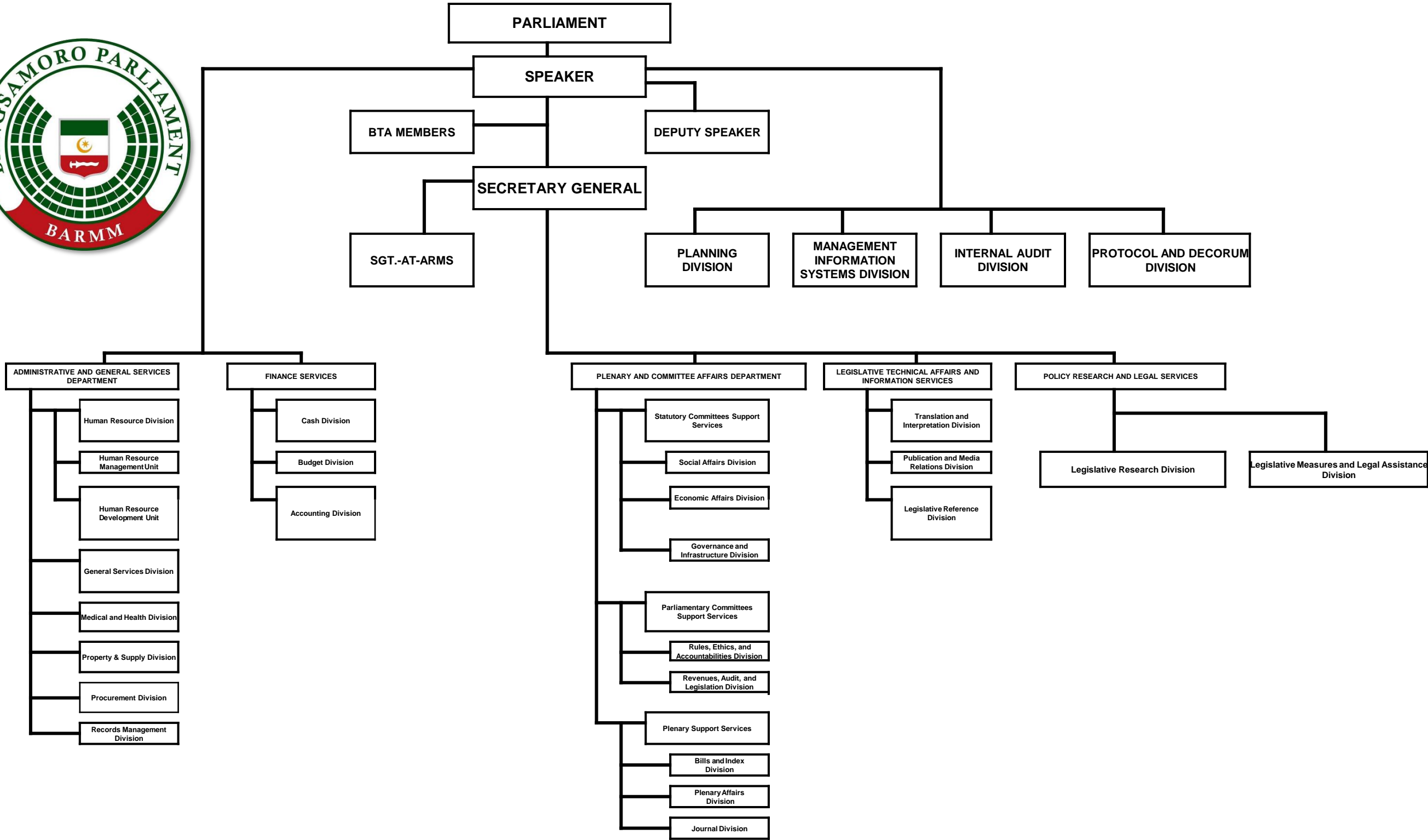

# BANGSAMORO PARLIAMENT ORGANIZATIONAL STRUCTURE

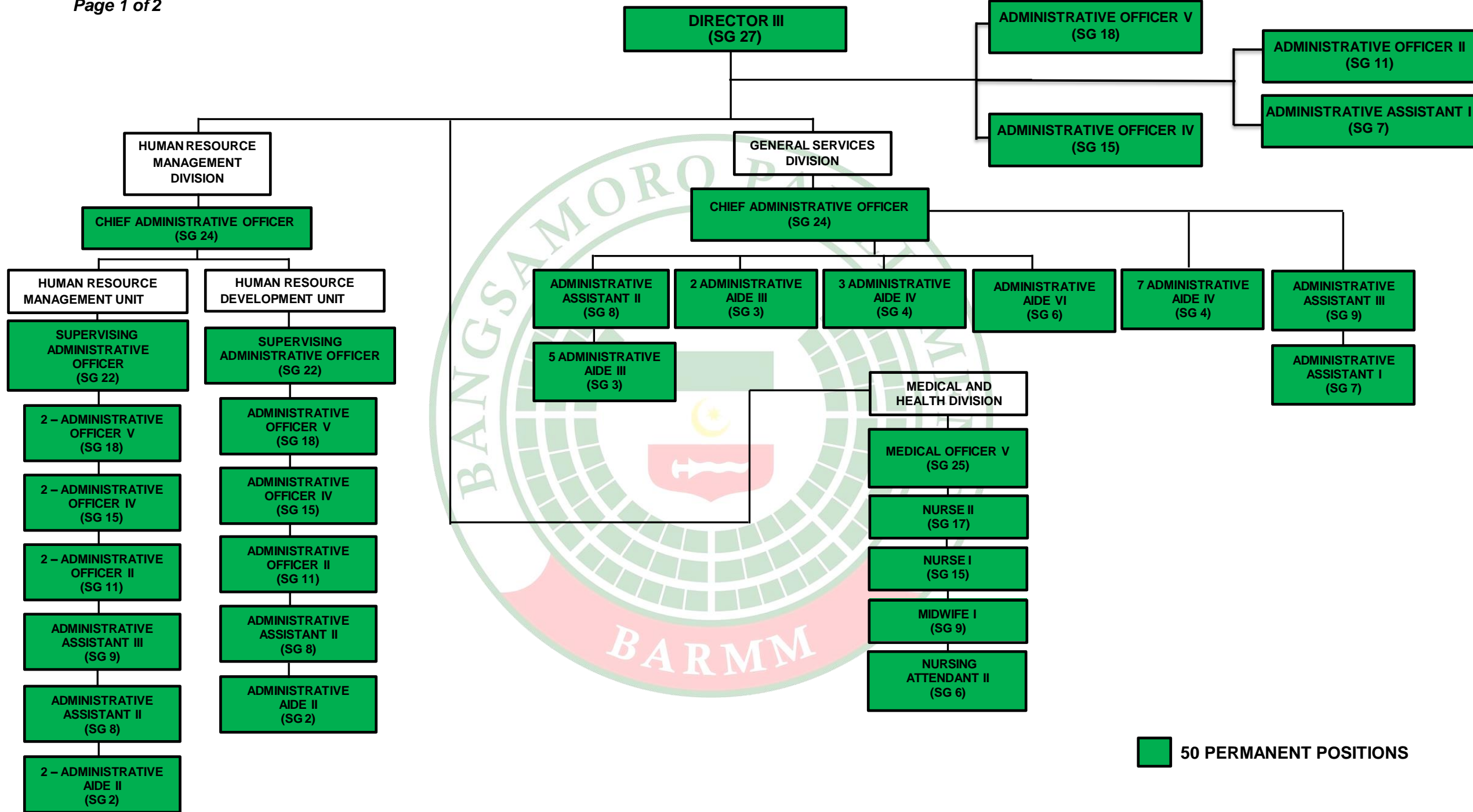
