BANGSAMORO AUTONOMY ACT NO. 114

Introduced by MP ZUL QARNEYN M. ABAS, M.D. and ATTY. MAISARA C. DANDAMUN-LATIPH

Begun and held in Cotabato City, Bangsamoro Autonomous Region in Muslim Mindanao, on the _____ day of _____, Year Two Thousand and Twenty One.

AN ACT CONSTRUCTING AND ESTABLISHING THE LANA O DEL SUR PROVINCIAL HOSPITAL TO BE LOCATED AT THE MUNICIPALITY OF TUGAYA, PROVINCE OF LANA O DEL SUR, BARMM AND APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

Be it enacted by the Bangsamoro Autonomous Region in Muslim Mindanao, Bangsamoro Transition Authority (BTA) Interim Parliament

SECTION 1. Short Title. – This Act shall be known as the “**THE LANA O DEL SUR PROVINCIAL HOSPITAL ESTABLISHMENT ACT OF 2021**”.

SECTION 2. Declaration of Policy. - It is a policy of the Bangsamoro Autonomous Region in Muslim Mindanao as provided under Section 22, Article IX of Republic Act No. 11054 otherwise known as the “Organic Law for the Bangsamoro Autonomous Region in Muslim Mindanao” to provide for a comprehensive and integrated health service delivery for its constituents and establish by law a general hospital system to serve the health requirements of its people and ensure that the individual basic right to life shall be attainable through the prompt intervention of excellent and affordable medical services.

SECTION 3. The Lanao del Sur Provincial Hospital (LSPH). – To implement the above-mentioned policy, a hospital facility is hereby established to be known as the **Lanao del Sur Provincial Hospital (LSPH)** to be located in the Municipality of Tugaya, province of Lanao Del Sur, BARMM. The **LSPH** shall be constructed, initially, with at least 25 bed capacity and shall start its operations under such capacity and capability as prescribed by the licensing standards of the Bureau of Health Facilities and Services under the Department of Health (DOH). The standard personnel, medical and office equipment and other facilities required shall likewise be provided to the hospital. The **LSPH** may be upgraded thereafter into a higher facility with a larger capacity upon the evaluation and recommendation of the Ministry of Health.

SECTION 4. Catchment area/coverage. – The LSPH shall serve primarily, but not limited to, the patients coming from the various parts of the province of Lanao Del Sur particularly those who do not have immediate and ready access to the existing related medical facilities in the province.

SECTION 5. Objective/s. – To provide a highly accessible, affordable, comprehensive total health care and hospital services to the BARMM constituents cited under Section 4 above and integrating in its system of operations all pertinent and relevant provisions under Republic Act No. 11223 otherwise known as the Universal Health Care (UHC) Act.

SECTION 6. Administration, Management and Organization. - The Lanao del Sur Provincial Hospital shall be under the administrative supervision of the Minister of Health who is hereby authorized to determine and approve the appropriate organizational structure for the management and operations of the facility.


SECTION 7. Appropriation. – The amount of Php 75 million pesos is hereby appropriated for the procurement of equipment and initial operations of the Lanao del Sur Provincial Hospital to include Pre-operating expenses, Personnel Services (PS) and Maintenance and Other Operating expenses (MOOE) as augmentation to the available budget and appropriation of the Ministry of Health for the construction of the LSPH facility structures. The BARMM- Ministry of Health shall incorporate in its succeeding annual appropriations the amount required for the continued operations of the hospital and its upgrading as it may deem necessary.

SECTION 8. Separability Clause. - In the event any provision of this Act or the application of such provision is declared invalid, the remainder of this Act shall not be affected by such declaration.

SECTION 9. Repealing Clause. – All laws and regulations under the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) government including those passed under the defunct Autonomous Region in Muslim Mindanao (ARMM) government regarding the construction, establishment and operations of the Lanao Del Sur Provincial Hospital not consistent with this Act are hereby repealed.

SECTION 10. Effectivity. – This Act shall take effect fifteen (15) days after its publication.
