
1. Another WHEREAS clause was inserted after the fifth Whereas clause stating the jurisdiction of the MOH-BARMM over the Iranon District Hospital, as follows:

WHEREAS, by virtue of Section 1, Article XVIII of the Bangsamoro Organic Law, the Iranon District Hospital shall be under the jurisdiction of the Ministry of Health in terms of accountability and responsibility as to its operation; and

2. The insertion of the title of the Mindanao Autonomy Act No. 196 in the first RESOLVED clause stated as follows:

RESOLVED, by the Bangsamoro Transition Authority, as it is hereby resolved, to recommend to the Ministry of Health to operationalize the Iranon District Hospital as mandated by Muslim Mindanao Autonomy Act No. 196 known as "AN ACT CREATING AND ESTABLISHING THE IRANON DISTRICT HOSPITAL IN THE MUNICIPALITY OF PARANG, PROVINCE OF MAGUINDANAO, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES".







"A RESOLUTION RECOMMENDING TO THE MINISTRY OF HEALTH (MOH-BARMM) TO OPERATIONALIZE IRANON DISTRICT HOSPITAL IN THE MUNICIPALITY OF PARANG, PROVINCE OF MAGUINDANAO"

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution provides that the State shall protect and advance the right to health of the people and instill health consciousness among them;

WHEREAS, Section 11, Article XIII of the 1987 Philippine Constitution further mandates that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged sick, elderly, disabled, women and children. The State shall endeavor to provide free medical care to paupers;

WHEREAS, Section 22, Article IX of Republic Act 11054 also known as the Organic Law for the Bangsamoro Autonomous Region in Muslim

Mindanao provides that the Bangsamoro Government shall protect and promote the right to health of the people and instill health consciousness among them. It shall uphold the people's right to have access to essential goods, health, and other social services that promote their well-being;

WHEREAS, Section 1, Article XVIII of the Bangsamoro Organic Law provides that "All subsisting laws enacted by the Autonomous Region in Muslim Mindanao Regional Legislative Assembly by virtue of authorities provided under Republic Act No. 6734, as amended by Republic Act No. 9054, shall be deemed valid and in effect, unless inconsistent with this Organic Law or repealed by laws passed by the Parliament."

WHEREAS, on July 13, 2006, Muslim Mindanao Autonomy Act No. 196 known as "AN ACT CREATING AND ESTABLISHING THE IRANON DISTRICT HOSPITAL IN THE MUNICIPALITY OF PARANG, PROVINCE OF MAGUINDANAO, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES" passed by the Fifth Regional Legislative Assembly - Autonomous Region in Muslim Mindanao was signed into law;

WHEREAS, by virtue of Section 1, Article XVIII of the Bangsamoro Organic Law, the Iranon District Hospital shall be under the jurisdiction of the Ministry of Health in terms of accountability and responsibility as to its operation.

WHEREAS, up to this date, the Iranon District Hospital was not fully operationalized despite the enactment of Muslim Mindanao Autonomy Act No. 196.

WHEREAS, seeing the need to establish and operationalize the Iranon District Hospital in the light of the demand for medical services in the Municipality of Parang and its neighboring municipalities, the Bangsamoro Transition Authority included in the 2020 Bangsamoro Appropriation Act a provision for capital outlay intended to be utilized for its operations;

WHEREAS, under the Health Facility Enhancement Program of the Ministry of Health, the Iranon District Hospital underwent major repairs for it to be serviceable and be of use;

NOW, THEREFORE, be it

RESOLVED, by the Bangsamoro Transition Authority, as it is hereby resolved, to recommend to the Ministry of Health to operationalize the Iranon District Hospital as mandated by Muslim Mindanao Autonomy Act No. 196 known as "AN ACT CREATING AND ESTABLISHING THE IRANON DISTRICT HOSPITAL IN THE MUNICIPALITY OF PARANG, PROVINCE OF MAGUINDANAO, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES";

RESOLVED, FURTHER, to forward this Resolution to the Honorable Chief Minister and to the Minister of the Ministry of Health for their immediate action.
