RESOLUTION CALLING THE OFFICE OF THE CHIEF MINISTER (OCM) AND THE MINISTRY OF HEALTH (MOH) TO IMPLEMENT THE UPGRADE OF DINAIG MUNICIPAL HOSPITAL FROM TEN (10) – BED CAPACITY INTO A DISTRICT HOSPITAL WITH FIFTY (50)- BED CAPACITY AS DECREED BY REPUBLIC ACT NO. 11330

WHEREAS, it is a policy of this BARMM government to provide for a comprehensive and integrated health service delivery for its constituents and to establish general hospital system that will serve the health requirements of its people and to ensure that the individual basic right to life shall be attainable through the prompt intervention of excellent and affordable medical services;

WHEREAS, Republic Act No. 11330 entitled, "An Act Converting the Dinaig Municipal Hospital in the Municipality of Datu Odin Sinsuat, Province of Maguindanao, into a Fifty (50)-Bed Capacity District Hospital to be now known as the Datu Odin Sinsuat District Hospital, Upgrading its Facilities and Professional Health Care, Authorizing the Increase of its Medical Personnel, and Appropriating Funds Therefor," was signed in to law April 17, 2019 and took effect fifteen days after its publication in the Official Gazette;

WHEREAS, Republic Act No. 11330, was published in the Official Gazette and a copy of which was uploaded in its official website, officialgazette.gov.ph, on June 20, 2019;

WHEREAS, up to this date, the Dinaig Municipal Hospital has not been upgraded. The hospital remains to have only Ten (10) actual and implementing bed capacity;

WHEREAS, the bed occupancy of the Dinaig Municipal Hospital is higher than its authorized bed capacity. In the Hospital Statistical Annual Report of MOH-BARMM in 2019, the Bed Occupancy Rate of the hospital has gone up to 470%, which means that the hospital is compelled to cater to number of patients far beyond its expected capacity;

WHEREAS, the mismatch in bed occupancy, compounded by lack of sufficient manpower and health services, hinder the quality of health care rendered to patients and significantly inadequate to sustain the growing health needs of the patients of

the hospital. Thus, the urgent realization of the law upgrading the Dinaig Municipal Hospital should be given precedence;

**NOW THEREFORE, BE IT RESOLVED,** as it is hereby resolved by the Bangsamoro Transition Authority to pass and approve this Resolution calling the Office of the Chief Minister (OCM) and the Ministry of Health (MOH) to implement the upgrade of the Dinaig

Municipal Hospital from Capacity as decreed b	n ten (10) – Bed Capacity by Republic Act No. 11330	into a district hospital w	ith fifty (50)- Bed
