COMMITTEE REPORT NO. 52

RE: Bangsamoro Transition Authority (BTA) Bill No. 76

Recommending for the approval of 2021 BARMM Proposed Budget with amendments.

Mr. Speaker,

The Committee on Finance, Budget and Management has the honor to report it back to the BTA, BTA Bill No. 76, entitled:

"AN ACT EXTENDING THE AVAILABILITY OF THE 2020 BANGSAMORO APPROPRIATIONS TO DECEMBER 31, 2021, AMENDING FOR THE PURPOSE SECTION 47 OF THE GENERAL PROVISIONS OF BANGSAMORO AUTONOMY ACT NO. 03, THE BANGSAMORO APPROPRIATIONS ACT OF FISCAL YEAR 2020."

After its deliberations, the Committee proposes the amendment of Section 47 to read as follows:

"Sec. 47. Cash Budgeting System. All appropriations authorized in this Act for Maintenance and Other Operating Expenses and Capital Outlay authorized in this Act shall be available for release and disbursement for the purpose specified, and under the same general and special provisions applicable thereto, until December 31, 2021.

The appropriations for Personnel Services authorized in this Act shall be valid for obligation and disbursement until December 31, 2020.

The MFBM is authorized to issue the necessary guidelines for the effective implementation of this Act."

Recommending its approval with amendments.



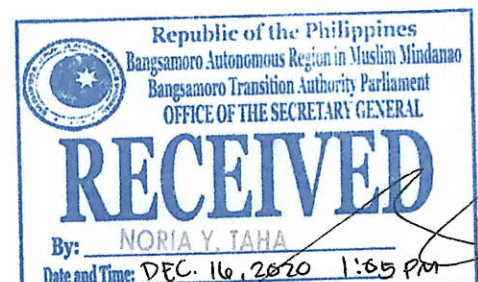
**AN ACT EXTENDING THE AVAILABILITY OF THE
2020 BANGSAMORO APPROPRIATIONS TO DECEMBER 31, 2021,
AMENDING FOR THE PURPOSE SECTION 47 OF THE GENERAL
PROVISIONS OF BANGSAMORO AUTONOMY ACT NO. 03, THE
BANGSAMORO APPROPRIATIONS ACT OF FISCAL YEAR 2020**

Section 1. Section 47 of the Bangsamoro Appropriations Act or Bangsamoro Act No. 3 is hereby amended to read as follows:

“Sec. 47. Cash Budgeting System. All appropriations authorized in this Act shall be available for release and disbursement for the purpose specified, and under the same general and special provisions applicable thereto, until December 31, 2020.

For FY 2020, the appropriations for infrastructure and other capital outlays shall be valid for obligation and disbursement until December 31, 2021. Further, appropriations for MOOE of Transitional Development Impact Fund (TDIF), Tulong Alay sa Bangsamorong Nangangailangan (TABANG), Quick Response Fund, Ayudang Medikal Mula sa Bangsamoro Government (AMBAG), Kapayapaan sa Pamayanan (Kapyanan), Marawi Rehabilitation Program, Family and Community Welfare Program, Child and Youth Welfare Program, Women’s Welfare Program, Older Person’s and Person with Disabilities Welfare Program, Emergency Assistance Program, Internal Affairs Program, Land Tenure Security Program, Sustainable Development for Agrarian Reform Beneficiaries in the Bangsamoro (SDAReBB), Agrarian Justice Delivery Program and the Contingent Fund shall likewise be valid for obligation and disbursement until December 31, 2021. The MOOE for all other programs not mentioned above shall be valid for obligation until December 31, 2020, while the delivery, inspection and payment shall be made not later than June 30, 2021.

The MFBM is authorized to issue the necessary guidelines for the effective implementation of the cash budgeting system”



Section 2. *Repealing Clause.* - All laws, decrees, executive issuances, rules and regulations inconsistent with this Act are hereby repealed or modified accordingly.

Section 3. *Effectivity.* - This Act shall take effect fifteen (15) days after its publication in a newspaper of regional circulation in the Bangsamoro Autonomous Region.
