Mr. Speaker:

The Committee on Social Services has the honor to report back to the Bangsamoro Transition Authority Parliament, Resolution No. 189, entitled:

**"RESOLUTION URGING THE OFFICE OF THE CHIEF MINISTER THROUGH THE LOCAL GOVERNMENT UNITS TO COME UP WITH AN APPLICABLE MECHANISMS THAT WILL MONITOR THE COMPLIANCE AND IMPLEMENTATION OF THE PROVISIONS OF REPUBLIC ACT NO. 11310 IN THE BANGAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO"**

With the recommendation that said Resolution No. 189 be approved with the following amendments:

1. The Title was amended to read as follows:

**"RESOLUTION CALLING ON THE OFFICE OF THE CHIEF MINISTER THROUGH THE REGIONAL ACTION COMMITTEE TO REGULARLY MONITOR AND REPORT ON THE STATUS OF COMPLIANCE AND IMPLEMENTATION OF THE PROVISIONS OF REPUBLIC ACT NO. 11310 IN THE BARMM"**

2. Add a Whereas Clause as paragraph 1 that reads as follows:

**"WHEREAS**, Republic Act No. 11310, "An Act Institutionalizing the Pantawid Pamilyang Pilipino Program is being implemented in the Bangsamoro Autonomous Region in Muslim Mindanao. The BARMM having the highest poverty incidence, there is a need for effective monitoring and compliance by the BARMM to realize the objectives of the said law."

3. The Resolving Clause was amended to read as follows:

"NOW, THEREFORE, BE IT RESOLVED, to call for the Chief Minister through the Regional Action Committee to regularly monitor and report on the status of compliance and implementation of the provisions of Republic Act No. 11310 in the BARMM."
