RECOMMENDING ITS APPROVAL WITH AMENDMENTS

Mr. Speaker:

The Committee on Social Services has the honor to report back to the Bangsamoro Transition Authority Parliament, Proposed Resolution No. 190, entitled:

**“RESOLUTION CALLING FOR THE ESTABLISHMENT OF AN INSTITUTIONAL MECHANISM TO ENSURE THE IMPLEMENTATION OF PROGRAMS AND SERVICES FOR PERSONS WITH DISABILITIES IN THE BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO”**

With the recommendation that said Resolution No. 190 be approved with the following amendments:

1. The Title is amended to read as follows:

**“RESOLUTION CALLING ON THE MINISTRY OF INTERIOR AND LOCAL GOVERNMENT (MILG) TO MONITOR THE ESTABLISHMENT OF INSTITUTIONAL MECHANISMS TO ENSURE THE IMPLEMENTATION OF PROGRAMS AND SERVICES FOR PERSONS WITH DISABILITIES IN THE BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO IN ACCORDANCE WITH REPUBLIC ACT NO. 7277, AS AMENDED BY REPUBLIC ACT NO. 10070.”**

2. The 10<sup>th</sup> Whereas Clause to read as follows:

**“WHEREAS**, to ensure compliance to Republic Act No. 7277 as amended by Republic Act No. 10070, the Bangsamoro Government shall formulate a regional policy mandating Local Government Units to establish a PDAO or appoint Focal Person for PWD in every province, city or municipality in the BARMM.”

Should be deleted

3. The 1<sup>st</sup> Resolving Clause to read as follows:

**“WHEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE PARLIAMENT** to request the Bangsamoro Government to establish an institutional mechanism to ensure implementation of programs and services on PWDs at the regional and local levels.”

Should be deleted

4. The 2<sup>nd</sup> Resolving Clause to read as follows:

**“RESOLVED FURTHER** that compliance to the provisions of Republic Act No. 7277 as amended by Republic Act No. 10070 shall be closely monitored in the BARMM to ensure the welfare of the PWDs in the region.”

Should be deleted

5. The 3<sup>rd</sup> Resolving Clause to read as follows:

**“Resolved Finally,** that copy of this resolution be furnished to the Office of Chief Minister, Ministry of Interior and Local Government, Ministry of Social Welfare and Development and other concerned ministries/offices and agencies for information and appropriate action.”

Should be deleted

6. Add a Resolving Clause that read as follows:

**“WHEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED BY THE PARLIAMENT** to call on the Ministry of Interior and Local Government to monitor the establishment of institutional mechanisms to ensure the implementation of Programs and Services for Persons with Disabilities (PWDs) in the Bangsamoro Autonomous Region in Muslim Mindanao in accordance with Republic Act No. 7277 as amended by R.A. No. 10070.”
