**RESOLUTION REQUESTING TO PROVIDE POINT-TO-POINT (P2P) TRANSPORT FOR BARMM EMPLOYEES WORKING IN BARMM DURING CORONA VIRUS DISEASE 2019 (COVID-19)**

**WHEREAS**, per Bangsamoro Autonomous Region in Muslim Mindanao Updated Guidelines on the Management of COVID-19, work in government offices may be at full operational capacity, provided applicable public health standards are observed;

**WHEREAS**, BARMM employees commuting to Cotabato City or from their point of origin to their point of destination are put in a predicament of being exposed to this deadly virus;

**WHEREAS**, to ensure that BARMM employees are able to go about their work and to avoid contracting this virus, it is recommended to provide P2P transport that will ferry them from a designated area or terminal to their official stations;

**WHEREAS**, the P2P transport means only one pick-up point and one drop-off point and follows a fixed schedule and route thereby lessening the hassle attached in the commuting BARMM employees;

**WHEREAS**, the Ministry of Transportation and Communication whose responsibility is to ensure the safety of the commuters is requested to make a



plan that will materialize the P2P transport that will conform to the foregoing guidelines and protocols as well as the procedures of the security sector;

It is hereby **RESOLVED**, to provide P2P transport for BARMM employees.
