BTA RESOLUTION No. 124

“RESOLUTION URGENTLY REQUESTING THE INTERIM CHIEF MINISTER AL HAJ MURAD EBRAHIM THROUGH THE MINISTER OF MINISTRY OF FINANCE AND BUDGET AND MANAGEMENT (MFBM), MP EDUARD U. GUERRA, TO ALLOCATE FUNDS FOR EMERGENCY FINANCIAL ASSISTANCE TO MILF AND MNLF-COMBATANTS AND THEIR FAMILIES PENDING THE RELEASES AND IMPLEMENTATION OF THE SPECIAL DEVELOPMENT AND REHABILITATION PROGRAM AS PROVIDED FOR IN THE ORGANIC LAW.”

Whereas, Section 1, Article XIV of Republic Act No. 11054 provides that as part of the normalization process, the Bangsamoro Government, shall formulate and implement a program for rehabilitation and development that will address the needs of Moro Islamic Liberation Front/Bangsamoro Islamic Armed Forces members and its decommissioned women auxiliary force, Moro National Liberation Front Bangsamoro Armed Forces members, and address the needs of internally displaced persons widows and orphans, and poverty-stricken communities.

Whereas, we have observed that based on our ground consultations and visitations in their communities that many of them are in dire need of financial assistance for their basic necessities to support their daily sustenance as they have failed to prepare for their source of revenue as a result of conflict affecting Mindanao as they experienced for how many decades;

Whereas, we also observed that the signing of peace agreement between the Government of the Philippines and the Moro Islamic Liberation Front till the establishment of the BARMM last January 21, 2019 plebiscite, there were no significant assistance extended to MILF and MNLF combatants and their families;

Whereas, by providing them said emergency Financial assistance would not only alleviate their present poor living conditions but will definitely help them and win their hearts towards the promotion of confidence building process between them and the national government to include the Regional Autonomous Government of the day.

Now therefore, be it,

RESOLVED, AS IT IS HEREBY RESOLVED by the Bangsamoro Transition Authority URGENTLY REQUESTING THE INTERIM CHIEF MINISTER AHOD “AL HAJ MURAD” B.
