A RESOLUTION MANDATING VARIOUS BANGSAMORO MINISTRIES AND OFFICES OF THE BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO (BARMM) TO ENHANCE THEIR RESEARCH DIVISION AND APPROPRIATE FUNDS THEREOF

Whereas, being aware of Section 21, ARTICLE IX of the Republic Act No. 11054, known as the "Organic Law for the Bangsamoro Autonomous Region in Muslim Mindanao" (BOL in short) states inter alia that the Bangsamoro Government shall ensure the full and effective participation of all sectors in the planning, programming, coordination, and implementation of scientific and technological researches;

Whereas, knowing that the power of information spells the difference between the First World, Second World and Third World Countries in the etymology of political science classifying various countries in the world socio-political-economy as those high class assume the highest echelon in world politics;

Whereas, considering that information gap may impair the progress towards development, national, regional and provincial levels; this fact applies to the BARMM in the face of the enormous challenges to inaugurate the much-needed reforms in the region;

Whereas, acknowledging the virtual decision-making and policy-formulation processes of various governmental institutions such as BARMM and its subsidiaries, that warrant reliable data and information as a valuable input in the process;

Whereas, given the easy accessibility of information on various milieus of field expertise, professions and literatures with the blessing of the Information Technological Era of Today's World, the risk of inapplicability of this information may be reduced through the research aimed at actual exposure or validation of data on the ground which enables the user gains a first hand and concrete information on certain subject matter;

Whereas, acting on the dire necessity to equip the ministries and heads of BARMM Agencies and offices to arrive at wise and well-informed decisions and strong policies to attain the moral governance in the BARMM;

Whereas, realizing that availability of the needed and correct information will save precious time, financial resources, mental and physical energies of the key stakeholders in the day-to-day operations of the government;

Wherefore, be it resolved as it is hereby resolved that this August Parliament will mandate various Bangsamoro Ministries and Offices to enhance their research divisions or units as the case may be;

Be it resolved further as it is hereby resolved that these ministries and offices should appropriate funds to their research division or if none, create such division or unit, appropriate funds for its creation designed to acquire information and data as an essential input and reference to their decision-making and policy making processes;

Be it finally resolved as it is hereby resolved that a copy of this resolution be furnished to all line agencies of the BARMM and its offices for implementation.
