**A RESOLUTION EXPRESSING SINCEREST AND DEEPEST CONDOLENCES

CHAIRMAN, SECRETARY ABUL KHAYR D. ALONTO**

WHEREAS, on September 5, 2016 and through an appointment from His Excellency President Rodrigo Roa Duterte, Secretary Abul Khayr D. Alonto became the first Muslim Chairman of the Mindanao Development Authority (MinDa);

WHEREAS, after the “Jabidah Massacre” in 1968, he organized the Muslim Youth Group, LAM ALIF, that eventually led to the conceptualization and organization of the Moro National Liberation Front (MNLF);

WHEREAS, Secretary Alonto was one of the original “Top 90” and was elected as MNLF Vice-Chairman, as he fought against the abuses of Martial Law during the Marcos dictatorship and paved the way for the establishment of an autonomous region in Mindanao;

WHEREAS, after the signing of the 1976 GRP-MNLF Tripoli Agreement, Secretary Alonto was elected as Assemblyman and became Interim Head of the Regional Autonomous Government, and was subsequently elected Speaker of the Regional Legislative Assembly;

WHEREAS, in 1994, he was appointed Ambassador Extraordinary and Plenipotentiary and Chief of Mission to Nigeria and 21 African States;

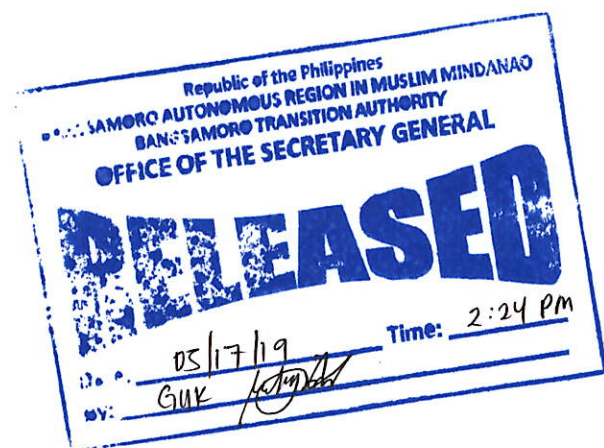
WHEREAS, in 2014, he participated in several deliberations in both the House of Representatives and the Senate to support the passage of what was then called the Bangsamoro Basic Law;

WHEREAS, in 1994, he was appointed Ambassador Extraordinary and Plenipotentiary and Chief of Mission to Nigeria and 21 African States;
