
**Whereas**, Section 2, Article VII of Republic Act No. 11054<sup>1</sup> Powers of Government. The powers of government be vested in the Parliament which shall exercise those powers and functions expressly granted to it in this Organic Law, and those necessary for, or incidental to, the proper governance and development of the Bangsamoro Autonomous Region. It shall set policies, legislate on matters within its authority, and elect a Chief Minister who shall exercise executive authority on its behalf.

**Whereas**, it is the Bangsamoro Government's commitment to commemorate this historical event for the Bangsamoro history.

**Whereas**, the efforts, sacrifices, tears, blood shed to attain this victorious moment shall be remembered and be imparted to our children and the generations to come.

**NOW, THEREFORE BE IT RESOLVED**, that Bangsamoro Transition Authority Parliament through the Ministry of Interior and Local Government shall issue directives to this effect.
