**RESOLUTION URGING ALL THE MINISTRIES, BUREAUS, OFFICES
AND LOCAL GOVERNMENT UNITS TO ADOPT AND INTEGRATE
VALUES RESTORATION PROGRAM AND PROVIDE
COMPREHENSIVE IMPLEMENTATION MECHANISM FOR THE
REALIZATION OF MORAL GOVERNANCE IN THE BANGSAMORO
AUTONOMOUS REGION IN MUSLIM MINDANAO (BARMM)**

WHEREAS, the Interim Chief Minister, Honorable Ahod “Alhaj Murad” Balawag Ebrahim called for moral governance as the policy-direction of the leadership in the administration of the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM);

WHEREAS, the Interim Chief Minister, Honorable Ahod “Alhaj Murad” Balawag Ebrahim also emphasized that Moral Governance shall be the overarching strategy and direction of all development initiatives in the BARMM;

WHEREAS, moral governance is the process of decision-making of public authority and by which such decisions are implemented or not implemented based on or in conformity to the generally accepted norms and standard of morality in the BARMM;

WHEREAS, crafting of and implementing policies, programs and projects should be guided by the principles of moral governance to attain genuine progress, inclusive development and lasting peace in the region;

WHEREAS, instituting moral governance is to have a just, fair, inclusive, transparent, accountable, legal and ethical government that is responsive to the needs of its constituents, and whose policy-decisions are consultative and collective;

WHEREAS, moral governance in the bureaucracy remains to be a formidable challenge in fighting against corruption, manipulation, divisiveness, nepotism, favoritism and other perceived social ills in the region;

WHEREAS, there is urgency in inculcating and living-by ethical and moral values among the officials, employees and partners directly or indirectly affiliated or working with the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) to be morally upright, effective and efficient instruments in running the Bangsamoro Government;

WHEREAS, the Revised Transition Plan (2019-2022) approved by the BTA on June 17, 2019 provides among others that “all applicants (newly hired) to the BARMM must also undertake Values Transformation Training as a compulsory requirement;” (page 78)

WHEREAS, the Civil Service Commission issued Announcement No. 40, series of 2017, dated October 2, 2017 institutionalizing **Values Restoration Program** as a soft approach of the government’s anti-corruption initiatives;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Bangsamoro Transition Authority to urge all the ministries, bureaus, offices, and local government units (LGUs) to adopt and integrate **Values Restoration Program and Provide Comprehensive Implementation Mechanism for the realization of Moral Governance in the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM)**;

RESOLVED FURTHER, that the Office of the Interim Chief Minister shall issue a memorandum order requiring all the ministries, bureaus, offices, and local government units to comply with this Resolution;

RESOLVED FURTHERMORE that a copy of this Resolution be furnished the Office of the Interim Chief Minister.
