PROPOSED RESOLUTION NO. 229

**RESOLUTION ADOPTING A CALENDAR OF SESSION FOR THE
SECOND REGULAR SESSION OF THE BANGSAMORO
TRANSITION AUTHORITY PARLIAMENT.**

WHEREAS, Section 5, Rule VI of the Parliamentary Rules, Procedures and Practices of the Bangsamoro Transition Authority of the Bangsamoro Autonomous Region in Muslim Mindanao (BTA-BARMM) provides that:

“The BTA shall convene its regular session on the third Tuesday of the month following Eid’l Fitr and shall continue to be in session for such number of days as may be determined through a legislative calendar.”

WHEREAS, Section 4, Rule XIII of the Parliamentary Rules, Procedures and Practices of the BTA-BARMM states that:

“The BTA shall hold plenary sessions every Tuesday to Thursday for the third and fourth week of the month that the BTA is not in recess. The Speaker shall open, conduct, and close the sessions.”

WHEREAS, adopting a Calendar of Session will guide the Members of the BTA Parliament in the performance of their legislative and constituency-servicing functions.

NOW, THEREFORE, be it




