## PROPOSED RESOLUTION NO. 28

# "A RESOLUTION CONSTITUTING A SPECIAL COMMITTEE FOR THE REHABILITATION/RECONSTRUCTION OF THE ISLAMIC CITY OF MARAWI, DEFINING ITS POWERS AND FUNCTIONS, AND PROVIDING FUNDS THEREFOR"

" WHEREAS, Article VII Section 11 of our approved Parliamentary Rules, Procedures and Practices provides for the creation or constitution of a Special Committee;"

"WHEREAS, the Islamic City of Marawi has been devastated and destroyed emotionally, financially, physically and spiritually when on the 23<sup>rd</sup> of May 2017, some unlawful elements enters violently the Islamic City and thus, the cause of its destruction in unaccountable proportions;"

"WHEREAS, since then and until now, there is developmental efforts being done by the National Government including the creation of the Task Force Bangon Marawi yet the Most Affected Areas in Marawi were still uninhabited, undeveloped and its residents were not allowed to be back/return in that particular areas;"

"WHEREAS, the Islamic City of Marawi is part of the territorial jurisdiction of the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) and the inhabitants therein are constituents of the Bangsamoro Autonomous Government;"

"WHEREAS, it is but proper and within its mandate, that the Bangsamoro Autonomous Government through the Bangsamoro Transition Authority should intercede for and in behalf of the residents of the Province of Lanao del Sur and the Islamic City of Marawi considering the urgent necessity for the Rebuilding. Reconstructing, Restructuring, and Rehabilitating the areas in the Islamic City of Marawi;"

"WHEREAS, as part of its effort, the Bangsamoro Autonomous Government through the Bangsamoro Transition Authority should constitute a Special Committee, in accordance with its Rules, that will deal exclusively on the Marawi City Rebuilding, Reconstruction, Rehabilitation and Restructuring;"

### "WHEREAS, the principal functions of the Special Committee are:

- Strongly collaborate and coordinate with the Task Force Bangon Marawi, Local Government Units in the area and other agencies of the National Government that is involved in the development of Marawi as a result of its destruction;
- 2. Submit alternative plans, designs and/or programs to the concerned agencies for the immediate development of Islamic City of Marawi;
- Make assessment on the extent of damage to the Most Affected Areas in the Islamic City of Marawi and its neighbouring areas that are similarly affected and/or damaged;
- 4. Make periodic assessment on the extent of assistance that the concerned agencies of the National Government and foreign agencies provides and make diligent efforts that the said assistance were properly distributed and/or delivered to the affected residents/inhabitants;
- 5. Make actual interviews, surveys and inspections to determine the actual situation on the affected areas;
- In the performance of its assigned tasks, the Special Committee may request the assistance and/or services of the personnel of the different Ministries in the Bangsamoro Autonomous Government from the different Ministers for courtesy and clearance;
- 7. It shall submit a written report to the Interim Chief Minister through the Bangsamoro Transition Authority on the assistance, financial, technical or human resources, that the Bangsamoro Autonomous Government can contribute in the Rebuilding, Restructuring, Rehabilitation and Reconstructing the Islamic City of Marawi;
- 8. It shall submit a periodic report to the Bangsamoro Transition Authority, if possible every session days, so that the Bangsamoro Autonomous

- Government can immediately act with dispatch on the immediate concerns of the affected residents/inhabitants;
- Submit to the Bangsamoro Transition Authority the needed reasonable, logical and legal, financial and technical assistance in order to perform its assigned tasks effectively and efficiently;
- 10.Perform such other matters in relation to the functions of the Special Committee as may be assigned to it by the Bangsamoro Transition Authority.

**NOW THEREFORE** be it Resolved as it is hereby Resolved to constitute a Special Committee for the Rehabilitation/Reconstruction of the Islamic City of Marawi.

**RESOLVED**, further, that copies of this resolution be furnished to the Interim Chief Minister and other Ministers in the Bangsamoro Autonomous Region in Muslim Mindanao.

**Resolved**, finally, that copies of this resolution be furnished the Chairperson of the Task Force Bangon Marawi, the Chief Local Executive of the Province of Lanao del Sur and the Islamic City of Marawi and other concerned National Agencies that are involved in the rehabilitation/reconstruction of the Islamic City of Marawi.
