

PROPOSED RESOLUTION NO. 339

RESOLUTION REQUESTING THE OFFICE OF THE PRESIDENT TO INSTRUCT THE PROFESSIONAL REGULATION COMMISSION TO STUDY THE NECESSITY OF ESTABLISHING PROFESSIONAL REGULATION COMMISSION REGIONAL OFFICE, SATELLITE OFFICE, OR SERVICE CENTER WITHIN THE BANGSAMORO AUTONOMOUS REGION

WHEREAS, the Bangsamoro Parliament recognizes the important role of the bangsamoro professionals towards the development of the Bangsamoro Autonomous Region;

WHEREAS, the Republic Act 8981 also known as An Act Modernizing the Professional Regulation Commission provides that the Professional Regulation Commission shall be attached to the office of the President for general direction and coordination;

WHEREAS, the Republic Act 8981 also provides that the Professional Regulation Commission is authorized to create Regional Offices as may be necessary to carry out its functions mandated by law;

WHEREAS, the Republic Act 11054 also known as the Bangsamoro Organic Law provides that the Bangsamoro Autonomous Region remains an integral, indivisible and inseparable part of the Republic of the Philippines;

WHEREAS, the Bangsamoro Autonomous Region remains one of the regions that do not have a Professional Regulation Commission Regional Office, satellite office, or service centers;

WHEREAS, the Bangsamoro Autonomous Region is home for a large number of registered professionals and would-be professionals;

WHEREAS, the private and state universities and colleges in the Bangsamoro Autonomous Region cater number of courses included in the regulated profession by the Professional Regulation Commission;

WHEREAS, the establishment of the Professional Regulation Commission Regional Office benefits the Bangsamoro registered professionals through reduction of travel time and cost in initial registration, renewal of professional identification card, and certification of board rating and passing;

WHEREAS, the establishment of the Professional Regulation Commission Regional Office will help the Bangsamoro Autonomous Region in the enhancement and maintenance of professional and occupational standard and ethics of the Bangsamoro professionals;

THEREFORE, it is RESOLVED, as it is hereby RESOLVED, that the Bangsamoro Transition Authority – Parliament Adopts a RESOLUTION REQUESTING THE OFFICE OF THE PRESIDENT TO INSTRUCT THE PROFESSIONAL REGULATION COMMISSION TO STUDY THE NECESSITY OF ESTABLISHING PROFESSIONAL REGULATION COMMISSION REGIONAL OFFICE, SATELLITE OFFICE OR SERVICE CENTER WITHIN THE BANGSAMORO AUTONOMOUS REGION.
