**RESOLUTION CONSTITUTING THE MEMBERS OF THE COMMITTEE ON  
AMENDMENTS, REVISION, AND CODIFICATION OF LAWS**

**WHEREAS**, Section 4 (6), Rule VII of the Parliamentary Rules, Procedures and Practices of the BTA Parliament stipulates that there shall be a committee to focus on the amendments and revision of laws:

***Committee on Amendments, Revision, and Codification of Laws.** – The Committee on Amendments, Revision, and Codification of Laws shall have seventeen (17) Members.*

*It shall exercise jurisdiction on all matters relating to the proposal to amend or revised the Organic Law of the Bangsamoro Autonomous Region in Muslim Mindanao, and the codification of codes and laws, including proposal to amend or revise these Rules or any provision thereof.*

**WHEREAS**, the Bangsamoro Transition Authority's priority is the passage of the seven (7) priority codes, with the Bangsamoro Administrative Code (Bangsamoro Autonomy Act No. 13) already approved in October 2020, and the Bangsamoro Civil Service Code approved in February 2021;

**WHEREAS**, the Bangsamoro Education Code and the Bangsamoro Local Government Code are currently on Second Reading within their respective committees;

**WHEREAS**, there is a need for the review of all these landmark legislation to check for potential corrections and consistency before the BTA ends its term;

**NOW, THEREFORE, be it**

**RESOLVED**, as it is hereby **RESOLVED**, to constitute the members of the Committee on Amendments, Revision, and Codification of Laws in order to facilitate the review and enhancement of our laws.
