A RESOLUTION STRONGLY CONDEMNING THE TWIN BOMBING ATTACKED AT SITIO TANJUNG, KAJATIAN, INDANAN MUNICIPALITY, JOLO-SULU LAST JUNE 28 (FRIDAY), 2019, RESULTED TO THE DEATH OF 8 PEOPLE AND 22 WOUNDED MOSTLY CIVILLIANS AS REPORTED BY GOVERNMENT AUTHORITIES THEREOF.

**WHEREAS**, the Bangsamoro inhabitants in the Autonomous Region in Muslim Mindanao (BARMM) after its ratification last January 21, 2019, are duty bound to protect, preserve and sustained the peace and tranquillity in the region to prevent lawlessness and the conduct of atrocities within our home land "the Bangsamoro territory" to avoid the entry of a terror activities;

**WHEREAS**, the twin bomb attacked occurred in the military camp in Indanan, Sulu just recently where innocent civilians are among the many victims considered to be a warning alarm for us to have an extra measures and proactive in order that it will never happen again;

**WHEREAS**, such fatal bomb attacked is considered to be an act of terrorism and violence and has no place in Islamic teachings and has no justification can be provided for it or in any kind of excuses for it as also declared by a notable and famous Muslim clerics from various Muslim countries in the world;


**WHEREAS**, Carrying bomb and make it explode in the midst of people is a savage act that deserve dispraise and condemnation for this is a crime against humanity that never coincides with the norms of conduct of every peace loving community;

**NOW THEREFORE**, after a Motion by MP Abdulmuhmin A. Mujahid, and unanimously seconded by all the BTA members present, it was ADOPTED and RESOLVED, as it is hereby APPROVED;

**That**, copies of this resolution be forwarded to the Provincial Government of Sulu and copy furnish the office of Secretary Carlito Galvez, Jr. of the office of the Presidential Adviser on the Peace process and reconciliation, for their information, reference and appropriate action.
