**“A RESOLUTION URGING THE BANGSAMORO GOVERNMENT TO
ESTABLISH AN INTERNATIONAL ISLAMIC UNIVERSITY IN THE
BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO .”**

Whereas, pursuant to the mandate of 1987 Constitution, under Article XIV, Section 1 provides “ The State shall protect the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all”. And Section 2 paragraph 2 states that “ the State shall establish, maintain and support a complete, adequate, and integrated system of education relevant to the needs of the people and society.”

Whereas, It is hereby declared a policy of the Bangsamoro Autonomous Government under Section 16, Republic Act No. 11054 that it shall be the top priority of the Bangsamoro Government to establish, maintain, and support a complete and integrated system of quality education. Further provides that, such other schools and institutions that maybe establish hereinafter , shall be deemed integral components of the educational system of the Bangsamoro Autonomous Region, and shall be govern by their respective charters.

Whereas, the establishment of the Bangsamoro International Islamic University (BIIU) is to heighten integration of the contemporary knowledge and divine knowledge as well as intensify the human thought in international arena through established institutions and academic activities and achieve excellence in every branches of knowledge.

Whereas, to ensure the Muslim Ummah’s ethical, moral, intellectual, social, economic and technological development in accordance with the values, ideals, principles and norms of Islam.

Whereas, the establishment of BIIU is to strengthen the education access of disadvantaged students, such as indigenous people, poor and deserving students, students from depressed areas, students from conflict areas and students who are children of Mujahideen and Mujahidat and all other who are deprived of education programs and services.

Whereas, to recognize and support the need for accelerating the Bangsamoro government program of "Education for All", to a more extensive professional and technical learning capabilities that will address the educational needs of the BARMM and other neighboring areas and competitive enough to meet the challenges of the changing times in the global educational environment.

Whereas, the Bangsamoro International Islamic University (BIIU) shall be dedicated to the search for truth and knowledge as well as the development of future Leaders in different field of specialization in the Bangsamoro Autonomous Region in Muslim Mindanao, regardless of tribe, beliefs, and groups in accordance with the principle of Moral Governance.

NOW THEREFORE, be it RESOLVED, as it is hereby RESOLVED, URGING THE BANGSAMORO GOVERNMENT TO ESTABLISH AN INTERNATIONAL ISLAMIC UNIVERSITY IN THE BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO ."
