**RESOLUTION ADOPTING A CALENDAR OF SESSION FOR THE

WHEREAS, Section 5, Rule VI of the Parliament Rules, Procedures and Practices of the Bangsamoro Transition Authority of the Bangsamoro Autonomous Region in Muslim Mindanao (BRA-BARMM) provides that:
