Whereas, having learned that His Excellency has appointed Justice Dimaampao as newest addition to the Justices of the Supreme Court of the Republic of the Philippines;

Whereas, considering that the Appointment of Justice Jaapar B. Dimaampao is most welcome historical act of the His Excellency President Rodrigo R. Duterte;
