A RESOLUTION EARNESTLY REQUESTING THE BANGSAMORO GOVERNMENT THROUGH THE MINISTRY OF HEALTH TO ESTABLISHED A HEMODIALYSIS CENTER WITHIN BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO SPECIFICALLY THE 7 AREAS OF FOCUS SUCH AS BASILAN, SULU, TAWI- TAWI, LANA DEL SUR, MAGUINDANAO, COTABATO CITY AND THE 63 BARANGAYS OF NORTH COTABATO AND PROVIDE FUNDS THEREOF

WHEREAS, Section 22, par 1 of Article IX of Republic Act No. 11054 also known as the Bangsamoro Organic Law states that the Bangsamoro Government shall adopt a policy on health that provides for a comprehensive and integrated health service delivery for its constituents, x x x;

WHEREAS, Section 22, part 2 Article IX of the same law further provides that The Bangsamoro Government shall protect and promote the right to health of the people and instill health consciousness among them. It shall also uphold the peoples' right to have access to essential goods health, and other social services that promote heir well-being, x x x;

WHEREAS, Sec 8, Article 9 of the Bangsamoro organic law states that The Bangsamoro Government shall provide, maintain, and ensure the delivery of basic and responsive health programs, x x x;

WHEREAS, Chronic Kidney Failure is one of the most dreadful disease that cause death not only in BARMM but all throughout the nation, meaning they need treatment through haemodialysis;

WHEREAS, due to exorbitant cost of hemodialysis, patient with Renal Failure cannot sustain this treatment for more than a year or sadly cannot afford to have few sessions of it;

WHEREAS, establishing a Hemodialysis Center would cater the region, including those and most importantly the indigent people in BARMM would be a giant step towards winning a battle in this health problem in combating the illness of Renal Failure;

WHEREAS, to establish its own Hemodialysis Center in the region to provide needy patients with life-extending service;

WHEREAS, 7 areas in the region needs the establishment of Hemodialysis Center, such as Basilan, Sulo, Tawi- tawi, Lanao del sur, Maguindanao, Cotabato City and the 63 Barangays of North Cotabato.

NOW THEREFORE, be it **RESOLVED**, as it is hereby **RESOLEVED**, to earnestly requesting the Bangsamoro Government through the Ministry of Health to establish a Hemodialysis Center within the Bangsamoro Autonomous Region in Muslim Mindanao the 7 areas of focus such as such as Basilan, Sulo, Tawi- tawi, Lanao del sur, Maguindanao, Cotabato City and the 63 Barangays of North Cotabato and provide funds thereof.
