"A RESOLUTION URGING THE PRIVATE ESTABLISHMENTS INCLUDING THE MINISTRIES, OFFICES AND LOCAL GOVERNMENT UNITS TO PROVIDE SAFETY AND HEALTH OFFICERS IN THEIR WORKPLACE IN COMPLIANCE TO THE OCCUPATIONAL SAFETY AND NEW HEALTH (OSNeH) STANDARDS"

WHEREAS, the Bangsamoro Government general welfare policy is to ensure and support, among other things, health and safety of its inhabitants;

WHEREAS, the "Act Strengthening Compliance with Occupational Safety and New Health (OSNeH) Standards" in all level of covered private establishments within Bangsamoro Autonomous region was passed before this body;

**WHEREAS,** Section 3 of the Act states that it shall apply to all private establishments, projects sites, including economic zone authority establishments, and all other places where work is being undertaken in all branches of economic activity;

**WHEREAS**, it is the policy of the Bangsamoro Government to guarantee the right of workers to humane condition of work, promote health and safety and preserve the comfort and convenience of the workers in all places of employment;

WHEREAS, accidents and health emergencies including the lifethreatening danger of COVID-19 pandemic in the workplace that are likely to cause death, illness or physical harm to the workers are possible;

**WHEREAS**, the office of the Ministry of Labor and Employment-BARMM deem the importance of applying this Act not only to private establishments but also to all ministries, offices and LGU workplace;

**WHEREAS,** under Section 10 of the OSNeSH policies and guidelines, and to ensure that safety and health program is observed and enforced, it is necessary for every workplace to have occupational safety and health personnel and facilities;
