**A RESOLUTION DIRECTING THE BANGSAMORO ECONOMIC  
DEVELOPMENT COUNCIL THROUGH THE BANGSAMORO  
PLANNING AND DEVELOPMENT AUTHORITY TO FORMULATE THE  
SOCIO-ECONOMIC PROFILE (SEP) OF THE BANGSAMORO  
AUTONOMOUS REGION IN MUSLIM MINDANAO**

**WHEREAS**, the creation of the Bangsamoro Autonomous Region, by virtue of Republic Act 11054 or the Organic Law, brought about changes in the new geographical configuration of the new Bangsamoro Autonomous Region, considering that Cotabato City and the 63 barangays in North Cotabato opted to join the new Bangsamoro Autonomous Region;

**WHEREAS**, the Bangsamoro Transition Authority Parliament, established the Bangsamoro Economic Development Council to serve as the planning, monitoring, and coordinating agency of the Bangsamoro government and the Bangsamoro Planning and Development Authority to serve as the Technical Secretariat of the Council;

**WHEREAS**, the old planning documents and other relevant materials including the socio-economic profile of the former ARMM are no longer relevant and useful for planning requirement of the Bangsamoro government under the new Bangsamoro Autonomous Region;

**WHEREAS**, the Philippines Statistics Authority (PSA) has recently released data which include, among others, data on population, poverty incidence;

**WHEREAS**, the Bangsamoro Autonomous Region programs and projects shall be incorporated in the Socio-Economic Profile;

**WHEREAS**, the new plan and investment program should be based on an updated and relevant SEP. Moreover, such SEP is also a good basis and input to legislative processes and formulation of policy measures;

**WHEREAS**, considering the aforementioned, there is a need to continue formulating the new plan and investment program of the Bangsamoro Autonomous Region that require a new and updated socio-economic profile of the new Bangsamoro Autonomous Region.

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the BTA Parliament, to pass and approve this Resolution: A Resolution Directing the Bangsamoro Economic Development Council through the Bangsamoro Planning and Development Authority to Formulate the Socio-Economic Profile (SEP) of the Bangsamoro Autonomous Region in Muslim Mindanao;

**RESOLVED FURTHER**, that a copy of the SEP be furnished to the Bangsamoro Transition Authority Parliament for legislative purposes.
