**RESOLUTION EXPRESSING PROFOUND SYMPATHY AND SINCERE
CONDOLENCES OF THE BANGSAMORO TRANSITION AUTHORITY
PARLIAMENT ON THE DEMISE OF THE HONORABLE DIDAGEN "DIGS" P.
DILANGALEN, FORMER REPRESENTATIVE OF THE 1ST DISTRICT OF
MAGUINDANAO WITH COTABATO CITY, HUMAN RIGHTS LAWYER, AND
PUBLIC SERVANT**

WHEREAS, Former Representative of Maguindanao with Cotabato City, Didagen "Digs" Dilangalen of Maguindanao died of illness on the morning of Saturday, November 6, 2021;

WHEREAS, Congressman Dilangalen represented Maguindanao's first congressional district with Cotabato City for nine (9) years from 1995 to 2004;

WHEREAS, Congressman Dilangalen was also the first and only representative of the defunct Shariff Kabungsuwan province in the 14th Congress from 2007 up to 2010;

WHEREAS, Congressman Dilangalen was a human rights defender, and a staunch supporter of the Bangsamoro struggle for self-determination;

WHEREAS, the five-hectare parcel of land where the largest mosque in the Philippines, Sultan Hassanal Bolkiah Mosque that can accommodate around 15,000 people was built, had been donated by the family of former Congressman Dilangalen;

WHEREAS, Congressman Dilangalen was a brilliant lawyer, and a fearless member of the House of Representatives who showed unwavering passion for public service as he pursued significant legislation for his constituency;

WHEREAS, the death of Former Congressman Dilangalen, a man who had exhibited a deep concern for Maguindanaons during his lifetime, is a great loss to the family he left behind and to the people of Maguindanao, whom he served faithfully for years;

NOW THEREFORE, BE IT RESOLVED BY THE BANGSAMORO PARLIAMENT, to express, as it hereby expresses, its most profound sympathy and sincere

condolences to the bereaved family of Congressman Atty. Didagen "Digs" Dilangalen, former Representative of the 1st District of Maguindanao with Cotabato City.
