**RESOLUTION RECOGNIZING MASIDING ALANGADI ALONTO, SR. AS A HERO OF THE
BANGSAMORO PEOPLE IN THE STRUGGLE AGAINST THE MARTIAL LAW
DICTATORSHIP OF THE MARCOS REGIME**

WHEREAS, Masiding Alangadi Alonto, Sr. extended his unrelenting support to the Bangsamoro cause even as the Marcos dictatorship retaliated against him by confiscating his family home, closing his businesses and banning him from traveling;

WHEREAS, Masiding Alangadi Alonto, Sr. played a crucial role in the organization of Moro resistance against repression that was marked by the Jabidah massacre of Moro soldier trainees, the wanton killing of Muslims by Ilaga vigilante groups and other crimes perpetrated and supported by the Marcos regime;

WHEREAS, Masiding Alangadi Alonto, Sr. aided in exposing to the international community the Marcos regime's abuses against Muslim communities and individuals and actively participated in protest rallies in the aftermath of the Aquino assassination even as his health was already failing;

WHEREAS, the Bantayog ng mga Bayani Foundation recognized MASIDING ALANGADI ALONTO, SR. on 30 November 2021 as a HERO in the struggle against the martial law dictatorship and honored them by engraving his name on the Bantayog Wall of Remembrance;

WHEREAS, the Bantayog ng mga Bayani Foundation also previously acknowledged HAROUN AL RASHID LUCMAN as a HERO on 30 November 2006, thus only two Moros have been given this high honor and recognition;

NOW THEREFORE, be it

RESOLVED, to similarly recognize **MASIDING ALANGADI ALONTO, SR.** as a HERO of the Bangsamoro people in the struggle against the Martial Law Dictatorship during the Marcos regime.

RESOLVED FURTHER, to forward a copy of this Resolution to the Bantayog ng mga Bayani Foundation, the Bangsamoro Commission for the Preservation of Cultural Heritage (BCPCH) and the family of Masiding Alangadi Alonto, Sr.
