"A RESOLUTION ADDRESSED TO HON. AHOD B. EBRAHIM, CHIEF MINISTER, BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO, COTABATO CITY RESPECTFULLY REQUESTING HIS GOOD OFFICE TO PROVIDE FINANCIAL ASSISTANCE AS SUBSIDY JUST ENOUGH FOR THE MAINTENANCE AND OPERATIONS OF BARANGAY KINUKUTAN, MUNICIPALITY OF AL-BARKA, PROVINCE OF BASILAN".

WHEREAS, Barangay Kinukutan is the only Barangay in the Philippines that does not have share from the Internal Revenue Allotment from the National Government;

WHEREAS, Barangay Kinukutan is one of the original Barangays of the municipality of Tipo-Tipo when the said municipality was not yet divided;

WHEREAS, Barangay Kinukutan was abolished during the time of the late and former President Corazon C. Aquino because accordingly the Barangay was considered as ghost Barangay since there were no elections conducted thereat for three (3) successive elections;

WHEREAS, the leaders of Barangay Kinukutan work hard for the recreation of the Barangay. Hence on November 24, 1994, the Commission on Election conducted a plebiscite for the approval of the creation of the Barangay;

WHEREAS, Barangay Kinukutan was not given IRA by the Department of Budget and Management for the reason the Barangay was created after effectivity of the local Government Code of 1991;

WHEREAS, should the Barangay in the future be included in the allotment of IRA from the DBM, then the supposed subsidy from the BARMM shall automatically be stopped;

NOW THEREFORE, as a member of this august body and as residents of Al-Barka Municipality, Province of Basilan, we move that the Bangsamoro Transition Authority will adopt a resolution respectfully requesting Hon. Ahod Ebrahim, Chief Minister, Bangsamoro Automous Region in Muslim Mindanao, Cotabato City, to provide financial assistance as subsidy just enough for the maintenance and operations of Barangay Kinukutan, Municipality of Al-Barka, Basilan Province, effective January 2020;
