**RESOLUTION REQUESTING MINISTRY ON INDIGENOUS PEOPLES AFFAIRS (MIPA) TO CONDUCT AN INVENTORY OF ANCESTRAL DOMAIN CLAIMS OF NMIPS WITHIN BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO (BARMM)**

**WHEREAS**, the Bangsamoro Government shall create a Ministry for Indigenous Peoples and shall have the primary responsibility to formulate and implement policies, plans, and programs to promote the well-being of all indigenous peoples in the Bangsamoro Autonomous Region in recognition of their ancestral domain as well as their rights thereto<sup>1</sup>;

**WHEREAS**, the Bangsamoro Government recognizes the rights of the indigenous peoples and shall adopt measures for the promotion and protection of the right of the NMIPs to Native titles or *fusaka inged*<sup>2</sup>;

**WHEREAS**, the Ministry serves as the primary agency responsible for the formulation and implementation of policies, plans, and programs to promote the well-being of all indigenous peoples in the Bangsamoro Autonomous Region in recognition of their ancestral domain as well as their rights thereto<sup>3</sup>;

**WHEREAS**, until this date, there are no available master list of ancestral domain claims within BARMM for the information of all concerned offices, agencies, ministries, non-government organizations and private institutions desiring to implement plans, programs or invest within ancestral domains;

**WHEREFORE, IT IS HEREBY RESOLVED**, requesting the MIPA to inventory and provide a master list of all ancestral domain claims within BARMM.
