BTA RESOLUTION NO. 78 S OF 2019

“RESOLUTION STRONGLY SUPPORTS THE MOVED OF THE SANGGUNIANG PANLUNGSOD OF THE CITY OF LAMITAN THROUGH RESOLUTION NUMBER 2019-197, APPROVED DURING THEIR INAUGURAL SESSION LAST JULY 17, 2019, REQUESTING THE BANGSAMORO TRANSITION AUTHORITY (BTA), TO CONSIDER LAMITAN CITY AS ONE OF THE PARLIAMENTARY DISTRICTS IN THE PROVINCE OF BASILAN.”

WHEREAS, during the thirteenth congress of the Philippines in its third regular session enacted into law Republic Act No. 9393, entitled an Act converting the Municipality of Lamitan in the Province of Basilan into a component city to be known as the “CITY OF LAMITAN” Hence, constitute already as political body corporate, endowed with the attributes of perpetual succession and posses of powers which pertains to a Municipal Corporation;

WHEREAS, Section 10, Article VII, R.A. 11054 provides that the Parliament of the Bangsamoro Transition Authority (BTA) shall have the powers to reconstitute by law the Parliamentary districts apportioned among the provinces, cities, municipalities, and geographical areas of the Bangsamoro Autonomous Region to ensure equitable representation in the Parliament;

WHEREAS, considering the City of Lamitan as one separate district in the Province would surely hasten the development not only in Basilan but would showcase the kind of Socio-Economic and holistic advancement stored for the areas within the Bangsamoro Autonomous Region in Muslim Mindanao.

NOW THEREFORE, be it resolved to adopt this resolution, as it is hereby resolved and approved that a “Resolution strongly supports the moved of the Sangguniang Panlungsod of the City of Lamitan through Resolution Number 2019-197, approved during their inaugural session last July 17, 2019, Requesting the Bangsamoro Transition Authority (BTA), to consider Lamitan City as One of the Parliamentary districts in the Province Of Basilan.”


