BANGSAMORO PARLIAMENT RESOLUTION NO. 82

INTRODUCED BY MEMBER OF PARLIAMENT EDDIE MAPAG ALIH

RESOLUTION URGING THE PAYMENT OF THE SALARIES OF THE FIVE (5) STAFF OF EACH MEMBER OF PARLIAMENT FOR MAY, JUNE AND JULY, 2019, AND REQUIRING THE MINISTRY OF BUDGET, FINANCE AND MANAGEMENT TO SOURCE FUNDS FOR THE PURPOSE

WHEREAS, the Bangsamoro Parliament started its legislative work since the Inaugural Session on March 29, 2019;

WHEREAS, the Members of Parliament started to recruit their staff who have since then assisted in their legislative work and other administrative functions;

WHEREAS, the Department of Budget and Management approved the five (5) positions, namely, Executive Assistant VI, Autonomous Region Legislative Staff Officer VI, Autonomous Region Legislative Staff Officer V, Executive Assistant III, and Executive Assistant II for the Members of the Bangsamoro Parliament only in August 2019. Consequently, the salaries of the staff shall take effect only in August 2019;

WHEREAS, the Bangsamoro Government adheres to the declared policy of the State that all government personnel shall be paid just and equitable compensation in accordance with the principle of equal pay for work of equal value;

NOW THEREFORE, be it resolved as it is hereby resolved,

1. That the five (5) staff of every Member of the Parliament shall be paid of their salaries in back wages for May, June and July 2019;

2. That the Ministry of Budget, Finance and Management shall source the needed funds from the lump sum released by the Department of Budget and Management for the salaries of the twenty four (24) Members and their respective staff, and other allocations of the former Regional Legislative Assembly for July-December, 2019,

3. That the Ministry of Budget, Finance and Management shall utilize the local funds of the Bangsamoro Government to supplement the required amount for the requested salaries, and

4. That the National Government augment the said amount, in order to cover the budgetary needs for this purpose in case of deficiency, if any.
