**“RESOLUTION RESPECTFULLY REQUESTING THE MINISTRY OF INTERIOR AND LOCAL GOVERNMENT (MILG) AND THE MINISTRY OF PUBLIC ORDER AND SAFETY (MPOS) IN CLOSE COORDINATION WITH THE PHILIPPINE NATIONAL POLICE OF THE BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO, TO CREATE TASK FORCE FOR AN IMPARTIAL INVESTIGATION ON THE DEATH OF AL-BARKA, BASILAN MAYOR DARUSSALAM S. LAJID, WOUNDING OF AKBAR MAYOR ALI A. SALI AND THE DEATH OF HIS DRIVER BARAD NURUDDIN IN ZAMBOANGA CITY LAST DECEMBER 6, 2021.**

**Whereas;** Section 2, Article 2 of the Bangsamoro Organic Law provides that the Philippine National Police shall be organized, maintained, supervised, and utilized for the primary purpose of law enforcement and maintenance of peace and order in the Bangsamoro in accordance with Republic Act No. 6975, otherwise known as the “Department of the Interior and Local Government Act of 1990, as amended by R.A. No. 8551, otherwise known as the “Philippine National Police Reform and Reorganization Act of 1998.”

**Whereas,** the two Basilan mayors Lajid and Sali together with their wives, children and some civilian’s escorts arrived at a private port in Baliwasan Seaside, Zamboanga City when they were spotted and shot by the four unidentified suspects eyewitnesses reported;

**Whereas,** the two town Mayors were passing through Zamboanga City from Basilan Province to supposedly attend the scheduled League of Municipalities of the Philippines meeting in Davao City last Tuesday of December 7, 2021 when the incident took place which barred them from attending the same occasion.

**NOW THEREFORE,** be it Resolved by the Bangsamoro Transition Authority (BTA), that a “Resolution respectfully requesting the Ministry of Interior and Local Government (MILG) and the Ministry of public Order and Safety (MPOS) in close coordination with the Philippine National Police of the Bangsamoro Autonomous Region in Muslim Mindanao, to create Task Force for an impartial investigation on the death of Al-Barka, Basilan Mayor Darussalam S. Lajid, and wounding of Akbar Mayor Ali A. Sali and the death of his driver Barad Nuruddin in Zamboanga City last December 6, 2021.
