**RESOLUTION EXPRESSING GRATITUDE TO HIS EXCELLENCY PRESIDENT  
RODRIGO ROA DUTERTE FOR APPOINTING ATTY. GUILING A. MAMONDIONG  
AS THE NEW SECRETARY OF THE COMMISSION ON MUSLIM FILIPINO (NCMF)**

**WHEREAS**, Section 1, Article VII of the 1987 Philippine Constitution vests executive power on the president of the Philippines. The President is the Head of the State of Government, and functions as the Commander-in-Chief of the armed Forces of the Philippines. As a chief executive, the President exercises control over all the executive departments, bureaus and offices;

**WHEREAS**, Executive Order No. 292, series of 1987 otherwise known as the Administrative Code of 1987 specifically provides for the powers of the President among others, The President of the Philippines has the mandate of control over all the executive departments, bureaus and offices. This includes restructuring, reconfiguring, and appointments of their respective officials. The Administrative Code also provides for the President to be responsible for the abovementioned offices' strict implementation of laws;

**WHEREAS**, Section 2, Article VII of the Republic Act 11054 or the Bangsamoro Organic Law. *Powers of Government*. The powers of government be vested in the Parliament which shall exercise those powers and functions expressly granted to it in this Organic Law, and those necessary for, or incidental to the proper governance and development of the Bangsamoro Autonomous Region;

**WHEREAS**, Section 3, Article V of the Republic Act No. 11054 or the Bangsamoro Organic Law. *General Welfare*. The Bangsamoro Government shall exercise the power expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of general welfare;

**WHEREAS**, Malacañang on 8 March 2022 announced that President Rodrigo Duterte has appointed Atty. Guiling A. Mamondiong as the new Secretary of the Commission on Muslim Filipino (NCMF);

**WHEREAS**, Atty. Guiling A. MAmondiong was the administrator for the Local Water Utilities Administration (LWUA); and

**WHEREAS**, this appointment brings honour and pride to the Bangsamoro people.

**NOW, THEREFORE, BE IT**

**RESOLVED**, by the Bangsamoro Parliament of the Bangsamoro Autonomous Region in Muslim Mindanao a resolution expressing gratitude to His Excellency President Rodrigo RoaDuterte for appointing Atty. Guiling A. Mamondiong as the new Secretary of the Commission on Muslim Filipino (NCMF).
