A RESOLUTION URGING THE MINISTRY OF HEALTH AND MINISTRY OF PUBLIC WORKS TO REHABILITATE AND REPAIR SELECTED PRIORITY BARANGAY HEALTH CENTERS SITUATED AT BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO (BARM)

WHEREAS, Section 8, of Article IX of the Bangsamoro Organic Law states The Bangsamoro Government shall provide, maintain, and ensure the delivery of basic and responsive health programs, x x x;

WHEREAS, Section 22, paragraph 2 of Article IX of the Bangsamoro Organic Law states that the Bangsamoro Government shall protect and promote the right to health of the people and instill health consciousness among them. It shall also uphold the peoples' right to have access to essential goods health, and other social services that promote their well-being, x x x;

WHEREAS, Rural Health Units and Barangay Health Centers are providers of public health service at the municipal and barangay levels. It is shown that the poorest of the population are the main users of government facilities yet these facilities have suffered neglect due to inadequacy of health budgets;

WHEREAS, lower level of care was bypassed even to simple primary cases because of deteriorating quality of the health facility, medical equipment and medicines. This is particularly disadvantageous to the poor who needs services the most;

WHEREAS, the Bito Barangay Health Center located at Barangay Capiton, Taviran, Maguindanao and Macaguiling Health Center, situated at Sultan Kudarat maguindanao are amongs the priority Health Centers that needs to be rehabilitate and repair;
