Mr. Speaker,

The Committee on Rules to which was referred

BTA Parliament Bill No. 46 entitled:

AN ACT DEFINING THE POWER OF APPOINTMENT IN THE BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO AND FOR OTHER PURPOSES

has been deliberated and respectfully recommending for its approval with amendments, to wit:

- 1. Paragraph (c) of Section 4 Appointing Authority shall be amended as follow:
- (c) The Speaker of the Parliament shall exercise administrative supervision over the legislative personnel, staff, and secretariat of the Bangsamoro Parliament, and shall be the appointing authority to all career positions in the Parliament including coterminous and contractual positions, as well as contracts of service thereat. Provided, that the speaker shall consult with the Chief Minister on the appointment of those applying for positions with salary grade 25 and above.
 - 2. Paragraph (d) of Section 4 Appointing Authority shall be amended as follow:
- (d) The Heads of Offices shall appoint officials and employees to positions with salary grade of 24 and below in their respective agencies or offices.
