Mr. Speaker:

The Committee on Health and Committee on Finance, Budget and Management have the honor to report it back to the Bangsamoro Transition Authority, BTA Bill No. 79, entitled:

AN ACT UPGRADING THE EXISTING WAO DISTRICT HOSPITAL IN LANA DEL SUR FROM ITS PRESENT LEVEL 1 WITH 25 BED CAPACITY INTO LEVEL 1 WITH 100 BED CAPACITY AND APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

After a thorough scrutiny, the Committee on Health and Committee on Finance, Budget and Management jointly submit to the Parliament, with the recommendation that it be approved with the following proposed amendments:

1. The title shall be amended to change the proposed level and bed capacity from Level 2 one hundred (100) to Level 1 fifty (50) bed capacity, to read as;

AN ACT UPGRADING THE EXISTING WAO DISTRICT HOSPITAL IN LANA DEL SUR FROM ITS PRESENT LEVEL 1 WITH A 25 BED CAPACITY INTO LEVEL 1 WITH AN AUTHORIZED 50 BED CAPACITY AND APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

2. In Section 1, the year "2020" after the word "OF" shall be replaced with "2022".

3. In Section 3, the number "2" after the word "Level" shall be replaced with the number "1"; and the number "100" after the word "with" shall be replaced with the number "50", to read as;

SEC. 3. Upgrading of the Wao District Hospital. -- The Wao District Hospital is hereby upgraded from its present level with 25 bed capacity into Level 1 with 50 Authorized Bed Capacity in accordance with the national standards set by the Bureau of Health Facilities and Services under the Department of Health (DOH). The existing building including its landscaping, medical and office equipment and other facilities, its operating funds and personnel are also hereby upgraded to include the needed construction and procurement thereof in order to meet the prescribed standards to the upgraded level.

4. In Section 6, the phrase "The amount of Two Hundred Six Million Pesos (Php. 206,000,000.00)" shall be replaced with the word "Funding".
