Mr. Speaker:

The Committee on Health and Committee on Finance, Budget and Management have the honor to report it back to the Bangsamoro Transition Authority, BTA Bill No. 89, entitled:

"AN ACT ESTABLISHING A LEVEL II DISTRICT HOSPITAL IN THE MUNICIPALITY OF MAIMBUNG, PROVINCE OF SULU, AND APPROPRIATING FUNDS THEREFOR."

After a thorough scrutiny, the Committee on Health and Committee on Finance, Budget and Management jointly submit to the Parliament, with the recommendation that it be approved with the following proposed amendments:

1. The title shall be amended by inserting the phrase 'with one hundred (100) bed capacity', to read as;

AN ACT ESTABLISHING A LEVEL II DISTRICT HOSPITAL WITH ONE HUNDRED (100) BED CAPACITY IN THE MUNICIPALITY OF MAIMBUNG, PROVINCE OF SULU, AND APPROPRIATING FUNDS THEREFOR

2. A clause shall be inserted after the title, to be read as;

Be it enacted by the Bangsamoro Transition Authority Parliament in session assembled:

3. In Section 1, the provision shall be amended as follows;

- a. the phrase "is hereby" shall be replaced with the word 'shall be'; the word "General" be replaced with "District"; and insert "(100)" after the word "one hundred"; insert the phrase "which shall be" after the words "Province of Sulu"; and to add the "en dash" sign with the word "SULU" after the acronym "IPHO"; and*
- b. the second paragraph provision of Section 3 shall be placed in Section 1 as second paragraph provision; the word "facility" shall be in its plural form "facilities"; the phrase "consistent with" shall be replaced with "based on"; the phrase "which shall be prepared by Maimbung Hospital administration in coordination with Sulu Integrated Provincial Health Office (IPHO-SULU)" shall be added in the provision, to read as;*

SECTION 1. There shall be established a Level II District Hospital with one hundred (100) bed capacity in the Municipality of Maimbung, Province of Sulu, which shall be under the direct administrative and technical supervision of the Sulu Integrated Provincial Health Office (IPHO-SULU).

Any future increase in bed capacity and upgrading of health care services and facilities shall be based on the annual hospital development plan which shall be prepared by Maimbung Hospital administration in coordination with Sulu Integrated Provincial Health Office (IPHO-SULU).

4. The provision of Section 2 shall be amended, to read as;

SEC. 2. The Ministry of Health (MOH-BARMM) specifically the regulation and licensing enforcement division (RLED) shall immediately include in the Ministry's program, the operational guidelines of a Level II facility with one hundred (100) bed capacity in accordance with the National DOH standards.

5. The provision of Section 3 shall be replaced with a new provision, to read as;

SEC.3. Funding for personnel services (PS), maintenance and other operating expenses (MOOE) shall be included in the annual General Appropriations Act of the Bangsamoro. The budget shall be apportioned in three (3) tranches, to start in calendar year 2022 with the following allocation: Year 1 - 40%, Year 2 -30%, Year 3- 30%.

6. The original provision of Section 3 shall be renumbered as Section 4 with the following amendments:

- a. the words "of Hospital" after the word "Chief" shall be deleted;
- b. the words "General" shall be replaced with the word "District";
- c. "Sulu IPHO" shall be spelled out in words as "Sulu Integrated Provincial Health Office" and to add "(IPHO-SULU)" after those words;
- d. the acronym "MOH" shall be spelled out in words "Ministry of Health" following with an "en dash" together with the acronym "BARMM";
- e. the word "developmental" shall be replaced with the word "operational";
- f. to delete the article "to" before the word "reflect" and shall add "ing" on the word "reflect";
- g. to delete the phrase "developmental goals";
- h. the phrase "of the hospital every year" shall be deleted;
- i. the phrase "programs, projects, activities" shall be inserted after the phrase "reflecting the";
- j. the phrases "The medical personnel, capital outlays" and "shall be based on the annual hospital development plan." shall be deleted, to read as;

SEC. 4. The Chief of Maimbung District Hospital, in consultation and coordination with the Sulu Integrated Provincial Health Office (IPHO-SULU), shall submit to the Ministry of Health-BARMM` an annual operational plan reflecting the programs, projects, activities and budgetary needs for the operation of Maimbung District Hospital.

7. Section 4 shall be renumbered as Section 5.

8. Section 5 shall be renumbered as Section 6.

9. Section 6 shall be renumbered as Section 7; the phrase " following its complete" shall be replaced with the phrase "after its"; the word "national" shall be deleted; and the words "Bangsamoro Autonomous Region" shall be inserted, to read as follows;

SEC. 7. This Act shall take effect after fifteen (15) days after its publication in at least two (2) newspapers of regional circulation in the Bangsamoro Autonomous Region.
