

# EXECUTIVE SUMMARY

The first quarter of 2023 has been marked by significant milestones and achievements as we continued to advocate for health, nutrition, and disaster preparedness. In this two-part report, we present the highlights of the Office of MP Dilangalen from January to March 2023 and the other activities about community social welfare, consultations and engagements, and staff development.

We have introduced a new bill called the "Bangsamoro Fast Food Labeling Act". We have also passed three resolutions concerning nutrition and health, and one resolution regarding governance. Meanwhile, the bill establishing the Northern Kabuntalan Hospital was already passed for the first reading.

For our advocacy projects, the year took off with our first psychospiritual training for the humanitarian workers of BARMM. MP Dilangalen sees the importance of bringing mental health awareness to light to improve one's overall well-being. For our humanitarian workers, the nature of the jobs may mean constant exposure to life's difficulties. This five-day seminar focused on discussing the participants' challenges and equipping them with tools and methods to help them in their work.

In line with enhancing hospital service, the office of MP Dilangalen sponsored the first round table discussion on Ibadah-friendly hospitals. The event was a launching pad for introducing the Ibadah-friendly hospital accreditation program to religious leaders and hospital representatives. By having Ibadah-friendly hospitals, we aim to improve our accommodation of Muslim health workers and patients and help them feel more at ease while in the hospital environment.

Towards the end of the first quarter, the Office of MP Dilangalen formalized Project HELP: Home Essentials for Local Patients. It is an assistance program for indigent, senior citizen patients who have just finished hospital treatment. This project intends to help ease patients' transition from hospital care to at-home recovery.

These are only the highlights of what we have done so far. We are grateful for our partners' collaborative efforts and for our staff's hard work. We look forward to continuing our work in service of the Bangsamoro people.

### ON HEALTH

### NORTHERN KABUNTALAN HOSPITAL

The proposed bill for the establishment of the Northern Kabuntalan Hospital, entitled AN ACT ESTABLISHING IN THE MUNICIPALITY OF NORTHERN KABUNTALAN, PROVINCE OF MAGUINDANAO DEL NORTE, A LEVEL I GENERAL HOSPITAL TO BE KNOWN AS THE NORTHERN KABUNTALAN MUNICIPAL HOSPITAL, AND APPROPRIATING FUNDS THEREFOR, approved on first reading on March 22, 2023.

## PHILHEALTH BENEFITS INFORMATION DRIVE

The resolution entitled RESOLUTION URGING THE MINISTER OF HEALTH, PHILHEALTH AND LOCAL GOVERNMENT UNITS TO CONDUCT LOCAL INFORMATION DRIVES REGARDING THE BENEFITS OF PHILHEALTH FOR ITS MEMBERS AND DEPENDENTS TO IMPROVE THE ACCESSIBILITY OF HEALTH SERVICES was referred to Committee on Health and Committee on Interior and Local Government.

### COMPLIANCE WITH EXPANDED SOLO PARENTS WELFARE ACT

The resolution entitled URGING ALL CONCERNED MINISTRIES, AGENCIES, OFFICES, LOCAL GOVERNMENT UNITS AND OTHER INSTRUMENTALITIES OF THE BANGSAMORO GOVERNMENT TO ENSURE SWIFT AND FULL COMPLIANCE WITH REPUBLIC ACT NO. 11861 OTHERWISE KNOWN AS THE "EXPANDED SOLO PARENTS WELFARE ACT" was referred to different committees.

# IMMUNIZATION OF BABIES AND CHILDREN

The resolution RESOLUTION REQUIRING THE MINISTRY OF HEALTH TO PROVIDE A PROGRESS REPORT ON THE IMMUNIZATION OF BABIES AND CHILDREN IN BARMM AND TO PROVIDE AN ACTION PLAN FOR REACHING ITS TARGET IMMUNIZATION RATE has been referred to different committees.

### "BANGSAMORO FAST FOOD LABELING ACT"

The bill entitled AN ACT REQUIRING ALL BRANCHES OF POPULAR CHAINS OF FAST FOOD RESTAURANTS OPERATING IN THE BANGMORO AUTONOMOUS REGION IN MUSLIM MINDANAO TO PROPERLY LABEL THEIR FOOD PRODUCTS AND CONDIMENTS AS "WITH PORK" TO DISTINGUISH THEM FROM FOOD PRODUCTS AND CONDIMENTS WHICH ARE NON-PORK, WITHOUT PORK OR WITHOUT PORK BY-PRODUCTS, AND FOR OTHER PURPOSES has been filed.

"A Resolution directing the Ministry of Health to expedite the processing of release of salaries and benefits of healthcare workers and non-healthcare workers involved in the Covid-19 response in the Bangsamoro Autonomous Region in Muslim Mindanao" has been referred to the Committee on Health

# ACCREDITATION FOR QUALITY MANAGEMENT SYSTEM

The resolution entitled RESOLUTION ENCOURAGING ALL MINISTRIES AND AGENCIES OF THE BANGSAMORO GOVERNMENT, AND LOCAL GOVERNMENT UNITS TO PURSUE QUALITY MANAGEMENT SYSTEM CERTIFICATION FROM LOCAL AND/OR INTERNATIONAL CERTIFICATION BODIES was adopted by the Parliament.

# Project HELP: Home Essentials for Local Pat

On March 21, 2023, MP Dilangalen and Dr. Ishmael Dimaren, representing the Cotabato Regional and Medical Center (CRMC), entered into a Memorandum of Agreement for the pilot implementation of the Home Essentials for Local Patients, or HELP program, in CRMC.

The HELP program is a recovery assistance program for indigent, senior citizens patients to be discharged from hospitals. MP Dilangalen recognizes the difficulty these patients face when transitioning to home care. Through HELP, the beneficiaries will receive homecare essentials like medicine, supplements, and food packages. These will aid them in continuing with their recovery in the comfort of their houses. This program will be officially launched in May 2023.

The HELP program began in Tawi-tawi through the leadership of MP Atty. Jet Lim. Meanwhile, MP Dilangalen envisions implementing this program in other public hospitals in Cotabato City and in the BARMM.

# Ibadah-friendly Hospital Certification Program of the Cotabato Regional Medical Center (CRMC)

Since December 2022, MP Dilangalen has been working closely with Dr. Sherjan Kalim, Chairman of the Muslim Spiritual Care Committee of Cotabato Regional and Medical Center (CRMC), for the Ibadah-Friendly hospital accreditation program. MP Dilangalen empathizes with Muslim health workers and Muslim patients in hospital care. Having served as a community doctor, he knows the challenges of practicing religion in the line of work. Patients during confinement likewise encounter similar difficulties.

On January 18, 2023, the office of MP Dilangalen sponsored the first round table discussion on creating Ibadah-friendly hospitals. Dr. Kalim introduced the draft of the Ibadah-friendly Hospital Certification Assessment tool, which will measure the partner hospitals' compliance with the program. Dr. Kalim also discussed the best practices from Indonesia's Shari'a Compliant Hospital Certification Program to inspire the program's implementation in the region.

The event was attended by Bangsamoro Darul Ifta Mufti Abu Hurairah A. Udasan, religious leaders from Muslim Mindanao Halal Certification Board, Jamiat Cotabato and Institute Technology, Hay'atul Ulama, and Committee on Dawah and Masjid Affairs, and by representatives from local hospitals.

The Ibadah-friendly hospital accreditation program is being piloted at CRMC, Maguindanao Provincial Hospital, and Buluan District Hospital.





# Islamic Psychospiritual Training for **BARMM Humanitarian Workers**

The office of MP Dilangalen, in collaboration with the Taha Foundation, UNIPHYL-Women, and the Cotabato City Health Office, conducted a 5-day mental health training for the Muslim humanitarian workers in BARMM.

Humanitarian workers play a critical role in the recovery of distressed areas, such as those affected by crises like natural disasters and epidemics. They work on the ground and are among the first responders to aid those most in need. Undeniably, the nature of their service also puts them in vulnerable situations. They closely witness the hardships of the people they help. This may cause mental and emotional exhaustion.

The Islamic Psychospiritual Seminar and Training consisted of 10 sessions with different activities per session. It was designed to be a safe space for discussion. The participants were encouraged to reflect on their experiences and discuss their shared learnings. Towards the end, the facilitators introduced methods and techniques to help them with their work.

The seminar received positive feedback from its participants. The most common suggestion was to have continuity with programs like this. It was also recommended to explore the possibility of installing psychospiritual staff in BARMM offices.







# Philippine Heart Month Celebration

The Office of MP Dilangalen celebrated Philippine Heart Month through various activities aimed to promote health consciousness, physical exercises and regular checkups.

The highlight of the celebration was the free zumba session done in partnership with New Vibes, a group of local Zumba instructors. The event, entitled "Tara, Mag-ehersisyo! Para sa Masiglang Puso", was attended by men and women who danced to their hearts' delight. The team of MP Dilangalen also offered free blood pressure and oxygen saturation checkups.







# Bangsamoro Foundation Day Celebration

The Office of MP Dilangalen participated in the celebration of the 4th founding anniversary of BARMM. MP Dilangalen viewed the occasion both as a celebration of the lives of the men and women who toiled to get us to where we are today, and a continuous reminder of the noble cause that the Bangsamoro have undertaken, along with the many sacrifices made, towards the realization of our shared aspirations.

The team of MP Dilangalen set up a booth at the Datu Kabilan Sema Hall, Bangsamoro Government Center for three days. The visitors received free snacks, free massage and were entertained with various games.







# National Women's Month Celebration

MP Dilangalen and MP Engr. Aida Silongan held a joint event celebrating the Bangsamoro women during National Women's Month last March 22, 2023. 
