MEMBER OF THE PARLIAMENT

Dr. Hashemi Nur Dilangalen is a firsttermer Member of Parliament of the Bangsamoro Transition Authority (BTA). As an MP, he is the Vice Chairman of the Committee on Health and member of various other committees.

MP Dilangalen was born and raised in Cotabato City. He grew up as the second eldest child in a family of six. He finished his basic and secondary education at Albert Einstein School in the same city. Early on, he already exhibited his leadership skills. While taking up his secondary education, MP Dilangalen also served as the President of the Sangguniang Kabataan Federation of Cotabato City. Consequently, he became a member of the Sangguniang Panlungsod of the city for three (3) years. This experience molded his heart for service and shaped his desire to dedicate his life's work for the Bangsamoro people.

MP Dilangalen took his bachelor's degree in Medical Laboratory Science from San Pedro College in Davao City. He then proceeded to accomplish his medical degree in Matias H. Aznar Memorial College of Medicine. After acquiring his medical license, he went back to the Bangsamoro region to serve as first, as Resident Physician of the Datu Odin Sinsuat Hospital, then as Rural Health Physician of the Integrated Provincial Health Office of Maguindanao and, as Municipal Health Officer of Northern Kabuntalan



In this time, he also headed the COVID Resbakuna Vaccination Hub in Northern Kabuntalan. Witnessing the predicament of his Bangsamoro brothers and sisters and the challenges they faced was selfawakening for him. Through his work on the ground, he was able to observe gaps in healthcare. He also learned firsthand the difficulties hurdled by the fellow health workers as they do their share in the delivery of healthcare services. He knew that something could and should be done. These experiences would then be his turning point in his career.

Having served for nine months as Member of Parliament, MP Dilangalen admits more is yet to be done. Nevertheless, he is thankful to the Almighty for the guidance and blessings. Insha Allah, with this, coupled with our sincere intent to be of service to the Bangsamoro, in the days ahead, we will move forward to achieve his goals.

EXECUTIVE SUMMARY

This Accomplishment Report has been prepared to be submitted to the Office of the President thru the Office of the Presidential Adviser on Peace, Reconciliation and Unity (OPAPRU). It serves as a comprehensive report on the outputs of the Office of MP Dr. Hashemi Dilangalen, Member of Parliament of the Bangsamoro Transition Authority, for the period September 2022 to June 2023.

With the intent to set its direction, the team of MP Dilangalen conducted a strategic planning workshop and came up with the following:

Vision: "To be an effective, responsive and relevant legislative and socio-political office in the BARMM"

Mission: "To enact laws on health, nutrition and disaster preparedness, and to spearhead community services for the district constituents through forging partnership and alliance with the multisectoral communities".

As a medical doctor and having served as a municipal public health worker, MP Dilangalen focused his service in advancing health, nutrition and disaster preparedness in the Bangsamoro Autonomous Region of Muslim Mindanao (BARMM). He views these three areas as the enabling foundations to achieve progress and just and lasting peace in the Bangsamoro region.

In the last three quarters since MP Dilangalen took his oath, he has passed relevant bills which were eventually enacted into laws, resolutions and motions predicated on improving the health conditions of our constituents and the situation of our health workers as well.

The proposed bill to create a hospital in Northern Kabuntalan already passed the first reading. In response to the appeal of concerned health and non-health workers, a resolution was passed to expedite the release of their salaries and benefits during the Covid-19 response and thereafter was acted upon favorably by appropriate offices. Moreover, through an adopted motion, four (4) hospitals were added to the coverage of Ayudang Medikal Mula sa Bangsamoro Government (AMBaG). MP Dilangalen also passed resolutions to look into the implementation of the Expanded Solo Parents Welfare Act, the immunization of babies and children in BARMM, and the dissemination of information regarding Philhealth benefits. MP Dilangalen further authored a bill to require proper food labeling of items with pork ingredients. And, through a resolution, MP Dilangalen urged all ministries and agencies to acquire Quality Management System certification. This was immediately adopted by the Parliament.

Furthermore, MP Dilangalen collaborated with different groups to launch programs and facilitate activities that advocate the advancement of health, nutrition and disaster preparedness in the communities of BARMM. Working alongside with the Chairman of the Muslim Spiritual Care Committee of Cotabato Regional and Medical Center (CRMC), together, they sponsored the first

round table discussion on the Ibadah-friendly hospital certification program in the BARMM. This program aims to improve hospital services which are compliant with the needs of patients particularly concerning their religious beliefs.

MP Dilangalen also launched Home Essentials for Local Patients (HELP), a recovery assistance program for indigent senior citizen patients. The recipients will receive a support package to help in their transition to home care after being discharged from hospitals.

In collaboration with the Taha Foundation, UNIPHYL-Women, and the Cotabato City Health Office, the team of MP Dilangalen organized an Islamic Psychospiritual Training for the BARMM Humanitarian Workers. This is deemed to be a safe space for discussion and a venue to acquire tools and methods to help them in their line of work.

With the team's commitment to service, the Office of MP Dilangalen has initiated relief operation efforts to provide immediate assistance to its constituents who were affected by calamities and fire accidents.

Finally, the team conducted occasional outreach activities to several communities and waged campaigns to further advance its advocacies in the community.

In pursuance of the mandates of the Parliament to enact laws to promote, protect and ensure the general welfare of the Bangsamoro people, and as elucidated in his vision and mission, MP Dilangalen aims to pursue goals for the betterment of the Bangsamoro people.

Specifically and consistent with the abovementioned, the following sections of this report presents the accomplishments and outputs of the office of MP Dilangalen for the last three quarters. Notwithstanding the fact that he is new to the position as a parliamentarian, being a medical practitioner by profession and experience, MP Dilangalen has achieved the following achievements with perfect attendance.
