This is the best chance to say thank you, Dr. Ameril S. Usman for all your hard work, effort, and unwavering commitment in rendering your utmost service for the health and safety of Bangsamoro people. Your exemplary commitment would not go unnoticed for you will be perpetually remembered.

# INTERPELLATION OF MP TAGO

MP Tago inquired whether the Body would adopt the 3 weeks of session in a month in accordance to their agreement during their caucus meeting or they would continue observing the 2 weeks session in a month. MP Basman responded that they would adhere to the 2 weeks session which was still within the context of the prevailing Parliamentary Rules. She added that when a new Parliamentary Rules would be approved, then a new resolution containing the Calendar of Session would be in order.

As to whether the Body should discuss the Calendar of Session at the moment so that there was no need to go back to the Parliamentary Rules and once again, amend the Calendar of Session, MP Basman replied that they were open to amending the proposed resolution accordingly in due time.

As to the reason on choosing March 31 as the day of the mandatory adjournment, MP Basman answered that according to their research, March 31 would be the last Thursday before the start of the month of Ramadhan and April 31 would be the first day of Ramadhan in 2023.

MP Tago cited Rule VI, Section 5 of the Parliamentary Rules, Procedures and Practices which provides that "the BTA shall convene its regular session once every year on the second Tuesday of the month after the month of Ramadhan (after *Eid'l Fitr*)..." He, however, stated that the Rules did not state when the mandatory adjournment would be, thus it needed to be clarified because it also stated that "...and not later than thirty (30) days before the opening of the next regular session." He reiterated that it needed to be clarified in order for it to be consistent with the existing Parliamentary Rules.

At this juncture, the Chair reminded the Body that they would observe the current Rules of the Parliament which they have adopted.
