Honorable Members of the Committee on Rules,

Assalaamu'alaykum wa Rahmatullah.

The following are among the key action points agreed upon during the 1st Committee Meeting of the Committee on Rules dated October 6, 2022:

- a. The Chairperson of the Committee on Rules is authorized to negotiate the conduct of committee activities under a synchronized calendar with the Chairpersons of the Committee on Accounts, Committee on Finance, Budget, and Management, as well as the Committee on Local Government, to expedite the passage of priority measures, i.e. Budget of the Bangsamoro Transition Authority for F.Y. 2023, the Bangsamoro Appropriations Act for F.Y. 2023, the Bangsamoro Electoral Code, and the Bangsamoro Local Government Code.
- b. The conduct of public consultations for the Bangsamoro Electoral Code and the Bangsamoro Local Government Code shall be done simultaneously, as far as practicable.
