1. On page 1, the title shall include the words **"AND MEMORIZERS"** such that the same shall now read:

"RESOLUTION AMENDING ADOPTED RESOLUTION NO. 97, RESOLUTION RECOGNIZING THE TOP-RANKED BANGSAMORO QUR'AN RECITERS AND MEMORIZERS WHO REPRESENTED THE COUNTRY IN VARIOUS INTERNATIONAL QUR'AN RECITING COMPETITIONS FOR AROUND HALF A CENTURY SINCE 1969"

2. On page 1, in the second WHEREAS clause, change the words "an evaluation committee was created for the purpose;" to "the Office of the Chief Minister recommended for the creation of a Technical Working Group (TWG)." It shall thus read:

"WHEREAS, to expedite the implementation of A.R. No. 97, the Office of the Chief Minister recommended for the creation of a Technical Working Group (TWG)."

3. On page 2, delete the first and second WHEREAS clauses and insert the following clause:

"WHEREAS, the TWG organized a validation committee to review the list of awardees mentioned in A.R. No. 97;"

4. On page 2, the third WHEREAS clause is reworded as follows:

"WHEREAS, upon thorough review by the validation committee, awardees are listed hereunder;"

5. On page 3, delete the first and second WHEREAS clauses.

6. On page 4, delete the first and second WHEREAS clauses.

7. On page 4, in the first resolving clause, insert the words "AND MEMORIZERS," thus:

"NOW THEREFORE BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the Bangsamoro Parliament to amend Adopted Resolution No. 97, RESOLUTION RECOGNIZING THE TOP-RANKED BANGSAMORO QUR'AN RECITERS AND MEMORIZERS WHO REPRESENTED THE COUNTRY IN VARIOUS INTERNATIONAL QUR'AN RECITING COMPETITIONS FOR AROUND HALF A CENTURY SINCE 1969."


8. On page 4, add a second resolving clause:

"RESOLVED FURTHER, in recognition of their feats, to request the Office of the Chief Minister through the Bangsamoro Commission for the Preservation of Cultural Heritage to award respective plaques of recognition and/or other tokens of appreciation as may deem fit to the above-listed winners."


