AUTHORSHIP SPEECH OF MP MACASALONG

MP Macasalong delivered the following authorship speech on Proposed

Our Silver Medalist Aevemelech Monteclaro and our Bronze Medalists - Maharani Cabanban Sali, Arol Kris De Guzman, Jabbar Abdul, Laleina Eowyn Chiong, Kyzelle Mea Mijares, Dhan Joseph Eligio, and Frances Antonette Dela Cruz.

For the Pomsae event, we recognize our Gold Medalists – Althea Laureigne Juanitez Juachon, Sittie Shamera C. Samanodin, Jabbar Abdul, and Dhan Joseph Eligio. Arran Ace Ambasa, our Silver Medalist. And our Bronze Medalists – Aevemelech Monteclaro, Guthrie Ferrer, Kyzelle Mea Mijares, Maharani Cabanban Sali, and Allayza Camille De Guzman.

These athletes have gone beyond self-discipline, combining it with a genuine passion for Taekwondo. And if we are to learn anything from our athletes, Mister Speaker, discipline, dedication, and love of sports are a powerful combination. Truly, worthy of emulation.

Commending our players is not just an acknowledgment of their talent and triumph but it also tells us that the hard work and determination of the Home of the Champion (HOTC) trainors and referees have propelled them to achieve this success.

The two HOTC coaches, Byron B. Betita and Jan Rae Mijares Cabano, as well as Robert John Cabaog, who won the Best Male Referee Special Award, are also recognized by this resolution, Mister Speaker.

Our very own players received an outpouring of good wishes and other forms of support from their schools. We also want to extend our congratulations to Saint Francis Episcopal School of Upi, Inc., Notre Dame of Upi, Inc., Notre Dame of Cotabato, Camp Siongco National High School, Cotabato State University- University Laboratory School, Sero Central Elementary School, Datu Candido Andong Elementary School, Broce Central Elementary School, Pedro C. Dolores Elementary School, and Borongotan Elementary School.

The perseverance and courage of our athletes in pursuing the highest distinction an athlete can present to the Bangsamoro community are unmatched. We are very fortunate to have a new generation of athletes representing us that are courageous, passionate, vocal in their support of other athletes, and unaffected by the challenges placed in their path.

I strongly believe that the best praise we can give them is to acknowledge their effort and boost sports development in the region so athletes like them could reach their full potential and be well-equipped for the world stage. Let us both maintain and sustain the enthusiasm and energy we showed at the Taekwondo Championships and support the next generation of world-class Bangsamoro athletes.

To all our Kyurogi and Pomsae athletes, you are all truly deserving of this commendation. And I pray and hope that you continue to be an inspiration to the Bangsamoro youth, continue to be humble, and continue to work hard.

The outstanding achievement of the Bangsamoro athletes in this Taekwondo Championships proves one thing, with consistent and continuous support for our athletes, Bangsamoro athletes could be most promising.

Therefore, Mister Speaker, and my dear colleagues, I urge this August chamber to officially acknowledge and commend the participants of the 2022 Smart/MVP Sports Foundation National Inter-school Taekwondo Championships for their unwavering commitment to represent the Bangsamoro region.

OPENING OF THE PERIOD OF INTERPELLATIONS

On motion of MP Dumama-Alba, duly seconded and there being no objection, the period of interpellations was opened.

INTERPELLATIONS OF MP AMPATUAN

MP Ampatuan prefaced her interpellations by manifesting that she wanted to be co-author of the resolution, saying that she joined the authors in commending the taekwondo champions in bringing 20 medals and bringing honor to the Bangsamoro.

MP Ampatuan inquired on the number of Bangsamoro participants that were sent to the competition, to which MP Macasalong answered that almost 2,000 students came from different schools in total for the competition.

When asked what the overall rank of the Bangsamoro participants was from amongst the other regions that participated in the competition, MP Macasalong responded that the only data they had was the number of medals that the Bangsamoro participants got.

As to whether there was assistance coming from any of the government institutions in the Bangsamoro to the schools who participated in the competition, MP Macasalong responded that they provided technical assistance in some ways thru the Ministry of Basic, Higher and Technical Education (MBHTE). He added that since the competition is school-based, the school provided the payment for the gym where the students were sent for their daily training.

At this time, MP Mawallil, one of the co-authors of the resolution, said that they were still gathering the assistance that were granted to the athletes. He noted that since they were also in the budget deliberation of the line agencies of the BARMM, he suggested that they could integrate it as a form of recommendation to the government agencies to strengthen their programs in terms of giving assistance to the award winning athletes.

MP Mawallil explained that the intent of the resolution was to congratulate the winning athletes and to start a conversation about the importance of giving premium to the young athletes. He expressed his hoped that they could give full support to the athletes in the following year.

At this point, the Chair informed the Body that the Taekwondo Competition was organized by the Philippine Taekwondo Association. He said that it is an organization that calls all schools who want to participate in the sports events. He added that it is up to the schools to decide whether they would join the competition or not.

INTERPELLATIONS OF MP AMBOLODTO

MP Ambolodto sought clarification as to whether they had not extended any assistance to the athletes, to which MP Mawallil responded that that they did not say that the regional government did not extend assistance to the athletes. He clarified that what they wanted to say was that they did not have any concrete data as to how far the assistance that were extended to the athletes, explaining that they assumed that they had extended support whether directly or indirectly to the athletes.

As to whether they were not certain that they had extended even transportation assistance to the students who were sent and participated, MP Mawallil replied in the negative, saying that they did not have a concrete information on it. He, however, said that assuming there was no assistance extended to the athletes, it was not too late for them to extend assistance or benefits to the athletes. He said that the Bangsamoro Sports Commission (BSC) could extend incentives to the athletes.

MP Ambolodto stated that the assistance would have to be included in a program that is developed for the purpose.

As to whether there are programs that are dedicated for the development of martial arts in the schools, MP Mawallil responded that he was not sure. He suggested that they could request the BSC to submit to the Parliament the list of programs as the Parliament was still deliberating the budget of the BSC. He opined that they could intervene by proposing policies that would strengthen sports development in the region.

On motion of MP Dumama-Alba, duly seconded and there being no objection, the period of interpellations was opened.

CLARIFICATORY QUESTION OF MP ARNADO

MP Arnado manifested that she joined the resolution in congratulating Mr. Kuraiz Alamada.

In the culture of the Bangsamoro, MP Arnado asked what is given to actually convey congratulations, saying that the Parliament should give more prestige and actual value to the recipient such as plaque or house and lot, to which MP Ramos responded that there should be institutionalization of incentives for the achievers coming from the BARMM. She said that the Parliament could pass a legislative measure that would institutionalize the incentives program for the achievers such as scholarship programs. AUTHORSHIP SPEECH ON BTA-PARLIAMENT BILL NO. 33.

In sponsoring BTA-Parliament Bill No. 33, MP Guerra stated that he was disappointed that the bill did not move despite the certification by the Chief Minister that it is an urgent bill. Thus, he appealed to the august Body to fast track its approval, saying that they could not further allow deferring the development in the region.

REFERRAL OF BILL TO THE APPROPRIATE COMMITTEES

On motion of MP Alba-Dumama, duly seconded and there being no objection, the BTA-Parliament Bill No. 33 was referred to the Committee on Environment, Natural Resources and Energy and Committee on Finance, Budget and Management.

MANIFESTATION OF MP PARCASIO

MP Parcasio shared to the Body that the MNLF-National Government Peace Pact on energy was of the most contentious issues resolved in Indonesia. In the agreement, he said that the revenues for energy will be shared 50-50 by the National Government and the Autonomous Government. He added that what was wonderful in the agreement was all applications for a license to explore, develop, and utilize energy or energy-based minerals within the Autonomous Region would be lodged before the Autonomous Government. He said that when the Autonomous Government receive application for such, then the Autonomous Government will recommend the approval or disapproval of the application to the Department of Energy. He added that when the license is approved for the development of energy by a private entity, it is the regional government that shall monitor and see to it that laws are observed. In that sense, he pointed out that directly or indirectly, the control and management of the energy development would be in the hands of the regional government.

AUTHORSHIP SPEECH OF MP GUERRA ON BTA-PARLIAMENT BILL NO. 34

In his sponsorship speech, MP Guerra stated that the GOCC will be launched by the National Development Company, Natural Resources Development Corporation and the Southern Philippines Development Authority. He highlighted that it would further develop the economic potential of the Bangsamoro through maximizing partnerships with private sectors or potential investors. He stated that to enhance the implore of public capital and broaden the ownership base for investment to fund their development initiatives, the best way to pursue the flow of private capitals is to ensure value and nondiscriminatory treatment of public and private sector entities in the process of development to which the GOCC comes in and it will be strong independent body system that will ensure consumer protection and enhance the competitive operation in the investment market while minimizing the financial risk exposure of the Bangsamoro people. He stressed that it is high time to create the GOCC and that it will also bring employment.

REFERRAL OF BILL TO THE APPROPRIATE COMMITTEES

On motion of MP Dumama-Alba, duly seconded and there being no objection, the BTA-Parliament Bill No. 34 was referred to the Committee on Rules and the Committee on Finance, Budget and Management.

AUTHORSHIP SPEECH OF MP ALAMIA

In behalf of the Government of the Day, MP Alamia delivered the following authorship speech on BTA-Parliament Bill No. 22:

Assalamualaykum wa rahmatullahi wa barakaatuhu.

The Bangsamoro struggle has always been rooted in the strength and faith of our grassroots communities, firm in the assertion of our right to self-determination. At the frontlines of the struggle are the mujahideen and mujahidat whose belief and conviction in our right to chart our own path as a people have defined the defense of our rights and freedoms.

Their collective struggle and sacrifice in the past have brought us to where we are in the present at the helm of an autonomous region that is in a political transition, one that allows us to pursue transitional justice and reconciliation in line with our hopes for just and lasting peace in the Bangsamoro. The success of this pursuit includes honoring the inheritance we have received from our mujahideen and mujahidat who have paved the way towards a better future for our people, making sure that former combatants and their families receive the support necessary for them to have a firm foothold in the future they helped build.

With this in mind, I hereby submit the Bangsamoro Mujahideen/Mujahidat Benefits System Bill to the parliament for adoption and approval.

As the Government of the Philippines (GPH) Chair of the Task Force for Decommissioned Combatants and their Communities (TFDCC), I know that both the national and regional governments have made an effort to support our mujahideen and mujahidat. But despite our best efforts, concerns and frustrations have been raised regarding the ongoing decommissioning process, especially when it comes to programs and mechanisms that are supposed to ensure aid and support for former combatants and their communities.

Recognition, reconciliation, and reintegration for them and the communities they have helped build and sustain in the midst of conflict are essential in the process of ensuring transitional justice.

The Bangsamoro Mujahideen/Mujahidat Benefits System Bill aims to address this by standardizing government support – setting up a benefits system that is sustained by the combined resources coming from the government, private funding, and investments. It shall cover all ex-combatants aged sixty (60) years old and above or, in case of their martyrdom, their surviving family members following a vetting system that will be implemented with the assistance of the Bangsamoro Human Rights Commission.

The benefits provided for by the bill include an educational plan, burial assistance, hospitalization benefits, a monthly old age pension or a death pension, and a disability benefit. These shall be assessed and delivered on a needs-based system, and managed by the Bangsamoro Veteran Mujahideen/Mujahidat Affairs Office which shall be institutionalized through the passage of the same bill.

We need not look far to imagine the impact this bill can have in our communities, especially when many of us here owe our own survival to family members who have fought for the Bangsamoro and the autonomy we now exercise. As members of parliament, the mandate we now hold is one that was not simply handed to us. Rather, this is part and parcel of the struggle we are honored to inherit – one that we must now win for the future we hope to build for our people.

We cannot win this struggle without acknowledging the suffering that thousands of martyrs, along with the loved ones they have left behind, have had to overcome in service of the Bangsamoro people and our assertion of our rights and freedoms. Passing this bill is therefore crucial and urgent, and I hope that we can work together to make sure that it is enacted into law as soon as possible.
