RESOLUTION NO. 300

RESOLUTION AMENDING THE CALENDAR OF SESSION OF THE FIRST REGULAR SESSION OF THE SECOND PARLIAMENT

WHEREAS, Section 4, Rule VI of the Parliamentary Rules, Procedures, and Practices of the Bangsamoro Transition Authority – Bangsamoro Autonomous Region in Muslim Mindanao states that:

“Section 4. Conduct of Sessions. — Plenary sessions shall commence at one o’clock in the afternoon on Mondays through Thursdays of the third and fourth week of the month. xxx”

WHEREAS, on *Safar* 24, 1444/September 20, 2022, the Bangsamoro Transition Authority Parliament, through Resolution No. 265, adopted a Calendar of Session to guide the Members of the Parliament in the performance of their legislative and constituency-serving functions;

NOW, THEREFORE, be it




