**“AN ACT ESTABLISHING AND CONSTRUCTING A LEVEL – I MUNICIPAL HOSPITAL
WITH FIFTY (50) BED CAPACITY IN GUINDULUNGAN MUNICIPALITY, PROVINCE OF
MAGUINDANAO TO BE KNOWN AS GUINDULUNGAN MUNICIPAL HOSPITAL
APPROPRIATING FUNDS FOR ITS FACILITIES AND PROFESSIONAL HEALTH CARE,
MEDICAL PERSONNEL AND FOR OTHER PURPOSES”**

Section 1. Short Title. — This Act shall be known as the “GUINDULUNGAN MUNICIPAL HOSPITAL”

Section 2. Declaration of Policy. — It is a policy of the Bangsamoro Autonomous Region in Muslim Mindanao to provide for a comprehensive and integrated health service delivery for its constituents and establish by law a general hospital system to serve the health requirements of its people and ensure that the individual basic right to life shall be attainable through the prompt intervention of excellent and affordable medical services. Towards this end, and in order to adequately respond to emergencies, disasters and emerging diseases, the Bangsamoro Government shall protect the interest and promote the well-being and the medical needs of the Bangsamoro People.

Section 3. Guindulungan Municipal Hospital. — There shall be established a level I general hospital with fifty bed capacity in Guindulungan Municipality in the Province of Maguindanao to be known as the Guindulungan Municipal Hospital.

Section 4. Integration of the Universal Health Care (UHC) Program. -- The establishment of the Guindulungan Municipal Hospital shall integrate into its system of operations all pertinent and relevant provisions under Republic Act No. 11223 otherwise known as the Universal Health Care (UHC) Act.

Section 5. Administration. — Upon the effectivity of this Act, the Guindulungan Municipal Hospital shall be under the administrative supervision of the Minister of Health who is hereby authorized to determine and approve the appropriate organizational structure for the management and operations of the hospital.

Section 6. Appropriations. — The amount necessary to carry out the provisions of this Act shall be included in the Bangsamoro Appropriations Act. Thereafter, funds necessary for the maintenance and operation of the hospital shall be provided in accordance with the provisions of the Bangsamoro Appropriations Act and other pertinent laws.

Section 7. Implementing Rules and Regulations - The BARMM-MOH shall promulgate the Implementing Rules and Regulations (IRR) of this Act within sixty (60) days after the enactment of this Act.


Section 8. Separability Clause. -- In the event any provision of this Act or the application of such provision is declared invalid, the remainder of this Act shall not be affected by such declaration.

Section 9. Effectivity - This Act shall take effect fifteen (15) days after its publication in a newspaper of regional circulation in the Bangsamoro Autonomous Region.
