CHIEF MINISTER TO AUTHORIZE THE GRANT OF EMERGENCY
ALLOWANCE AND OTHER BENEFITS IN THE OBSERVANCE OF
RAMADHAN TO ALL PERSONNEL AND EMPLOYEES OF THE
BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO**

WHEREAS, it is paramount that the Bangsamoro Government must recognize the customs and traditions of all people in the region and the indispensability of these customs and traditions in forging the unity of the constituents and pursuing the wholistic development of the region;

WHEREAS, with the establishment of the Bangsamoro Region, through the enactment of RA 11054, otherwise known as the Bangsamoro Organic Law, the region can now promulgate actions which are more culturally appropriate and responsive to the needs of the people;

WHEREAS, Ramadhan is the ninth (9) month of the Islamic lunar calendar where Muslims observe a month-long fasting, reflection, and prayers. It is the month of Ramadhan that Muslim all over the world commemorate the first revelation of Prophet Muhammad (S.A.W) and fasting in this month is obligatory for all Muslims as it is considered one of the five pillars of Islam;

39 **WHEREAS**, Ramadhan is an equally significant occasion celebrated
40 globally – similar to that of the Christmas day where all government and
41 private employees are given the 13th month pay equivalent to one (1) month
42 basic salary pursuant to Presidential Decree No. 851 as modified in
43 Memorandum Order No. 28, Series of 1986;

45 **WHEREAS**, providing Ramadhan allowance to all personnel and
46 employees of the BARMM is one way to motivate them to work harder and be
47 more productive even in the difficult time of the month-long fasting and dusk-
48 to-dawn prayers;

49
50 **WHEREAS**, the grant of emergency allowance and other benefits will
51 sourced upon the determination of the Ministry of Finance, and Budget and
52 Management.

53
54 **WHEREAS**, that the Office of Chief Minister shall promulgate the
55 qualifications of eligible for the said allowance, but shall include in the grant,
56 contractual employees and job orders.

58 **NOW, THEREFORE, BE IT RESOLVED**, as it is hereby resolved by the
