28 RESOLUTION

29 CALLING ON ALL THE MINISTRIES, AGENCIES, AND OFFICES, INCLUDING
30 THE LOCAL GOVERNMENT UNITS OF THE BANGSAMORO, TO OBSERVE,
31 COMPLY, AND MONITOR THE IMPLEMENTATION OF THE PROVISIONS OF
32 REPUBLIC ACT NO. 7277, KNOWN AS THE MAGNA CARTA FOR PERSONS
33 WITH DISABILITY", AS AMENDED

34 WHEREAS, Section 2 of Republic Act No. 7277, otherwise known as the "Magna Carta
35 for Persons with Disability," recognizes that persons with disability are part of Philippine
36 society with equal rights as other people and thus obliges the State to give full support to
37 the improvement of their total well-being and their integration into the mainstream of
38 society;

39 WHEREAS, the Magna Carta for Persons with Disability, as amended by Republic Act
40 No. 10524, guaranty "equal opportunity for suitable employment" and parity rights to
41 "terms and conditions of employment, compensation, privileges, benefits, fringe benefits,
42 incentives or allowances";

43 WHEREAS, Republic Act No. 10524 expanded the coverage of the said law to include *all*
44 *government agencies, offices, or corporations* that are mandated to reserve for persons
45 with disability at least one percent (1%) of all the positions therein; while private
46 corporations with more than one hundred (100) employees are encouraged to do the
47 same;

48 WHEREAS, Section 21 of the Implementing Rules and Regulations of Republic Act No.
49 10524 requires that *all government agencies shall be responsible for monitoring*
50 *compliance of all offices/attached units under its jurisdiction/supervision* on the
51 requirement of reserving at least one percent (1%) of all positions for Persons with
52 Disability (PWD);

1 **WHEREAS**, Section 7 of Republic Act No. 11054, otherwise known as the “Bangsamoro
2 Organic Law,” declares that the Bangsamoro Government shall ensure every Filipino
3 citizen in its territorial jurisdiction the provision of the basic necessities and equal
4 opportunities in life; and that it shall promote social justice in all aspects of life and phases
5 of development;

7 **WHEREAS**, to ensure that persons with disability within the Bangsamoro Region enjoy
8 equal opportunities in employment, compliance by the LGU and all concerned agencies
9 with RA No. 10524 or the “Act Expanding the Positions Reserved for Persons with
10 Disability” is of paramount significance;

12 **NOW, THEREFORE**, be it **RESOLVED**, as it is hereby resolved, by the Bangsamoro
13 Transition Authority, to **CALL ON ALL THE MINISTRIES, AGENCIES, INCLUDING**
14 **THE LOCAL GOVERNMENT UNITS OF THE BANGSAMORO, TO OBSERVE,**
15 **COMPLY, AND MONITOR THE IMPLEMENTATION OF THE PROVISIONS OF**
16 **REPUBLIC ACT NO. 7277, KNOWN AS THE MAGNA CARTA FOR PERSONS WITH**
17 **DISABILITY”, AS AMENDED;**

19 **RESOLVED FURTHER**, that a copy of this resolution be forwarded to all the ministries,
20 agencies, offices, and local government units in the Region for their immediate
21 information and compliance.
